Brief Details.

On the above mentioned time and date, I was riding (Motorcycle Plate Number: JSX2946) along Moulmein Road. When approaching the traffic light, one car (Subaru, SKE 9226A) dashed out from Mandalay Road which is on my left side. I did not have time to stop my motorcycle, as such, I collided with the car. My face hit onto the car and I fell down to my left side. I was concussed. The driver and one other passerby assisted to carry me to the roadside. Subsequently, the ambulance arrived and I was conveyed to Tan Tock Seng Hospital conscious. I was then discharged the next day (30/06/2022) and was given 5 days of MC (29/06/2022 to 03/07/2022). My motorcycle was towed on the day of the accident and I have not seen my motorcycle ever since. I wish to state that I did not managed to get the driver's particulars.

On 29/06/2022, I was contacted by Investigation Officer (Suffian, 65476247) through WhatsApp and was instructed to lodge a police report. I was also informed that there was a witness during the accident (Yvonne, 96466747) and her vehicle plate number is SLC9081Z.

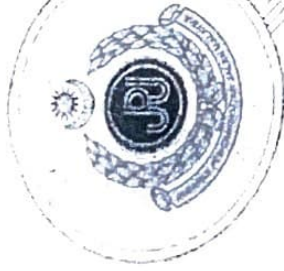
