We act for Tokio Marine, the insurers of motor vehicle number SML 1676B and are instructed as follows:-

1. On 23 Feb 2021, there was an accident at Sembawang Road when the insured's car collided with the left side of power-assisted bicycle (PAB). The rider was injured. The PAB is said to have been damaged.
2. We are defending the insured in DC/DC 895/2022.

3. Tokio Marine have requested us to write to you in relation to the claim for damage to the PAB. The relevant information are as follows:-
 - a) The PAB is FIIDO-Black (36V 10.4AH) UL 2272. There is an invoice dated 10 September 2019 from Warehouse SG Pte Ltd to show it was purchased at \$866.00. **A copy is attached.**
 - b) The Plaintiff claims that because of the accident, the PAB is a total loss. There is no survey report. We have scene photos as well as other photos, **copies attached.**
 - c) The Plaintiff has given another invoice from ABLE dated 13 March 2021 for Phoenix HD 4 wheels, purchased for the sum of \$1,899.00, **copy attached.**
4. Our clients wants to know whether you can look at the pictures and if necessary, to consider inspection if the PAB is available and issue a report to comment on the following:-
 - a) Could the PAB have been repaired and if so, how much would it cost.
 - b) If the PAB was a total loss, would there be any salvage value and if so, how much.
