"At approximately 9.20pm, while exiting PIE exit 36 towards Westwood Secondary School, I (SKC7177G) was involved in a head to rear collision with SKX7507C. Approaching Jalan Bahar road, I judged SKX7507C to have exited the PIE slip road and proceeded to check my blind spot and for any oncoming traffic. I saw that the traffic was clear and proceeded to exit the PIE slip road as well but realised that SKX7507C had abrupted stopped just outside the slip road. I could not react in time and rear ended SKX7507C. The male driver of SKX7507C explained that he performed an e-brake to avoid an incoming taxi which I had judged to be so far away that I, as the car behind SKX7507C, could exit safely without any threat of collision. I noted that the male driver and his 2 female adult passengers of SKX7507C were physically unhurt. One of the female passengers of SKX7507C also left in another private vehicle almost immediately after the collision and before I could speak to her. After exchanging particulars and agreeing on letting our respective insurance companies take over the matter, the male driver and his remaining female passenger also left in their vehicle. I have a video of the accident which will be sent to eve boon@spf.gov since I am unable to upload it through this website."
