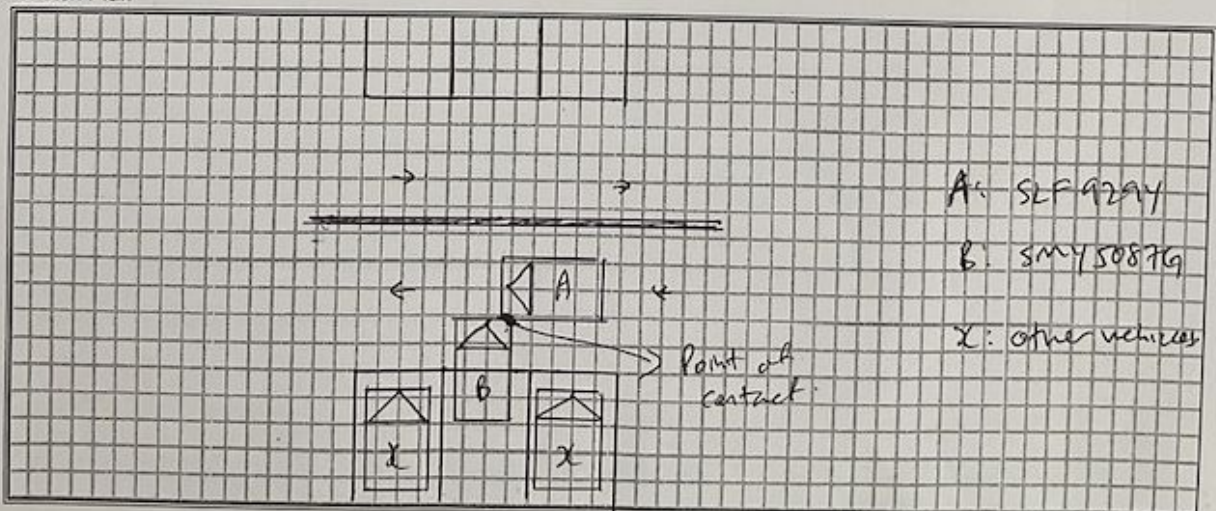

Sketch Plan




Describe Circumstance of the Accident


There were no injuries. That is all.


