I would like to report an accident that took place PIE (Changi) - lamp post #990, just before ERP gantry between my motorcycle (FBJ4587X - Blue FZ16) and a car (SNE32R - Black Mercedes). Ms. Ho Chiew Siang, NRIC: S7626980G, driver of the car hit me from behind on lane 1. Due to evening traffic, I was roughly at 55 km/hr when the accident occurred. My right arm and leg were bruised and I felt pain in my knee. Traffic police and Paramedic who were on hand to help asked if I could feel my knee and when I could, dressed my open wound. 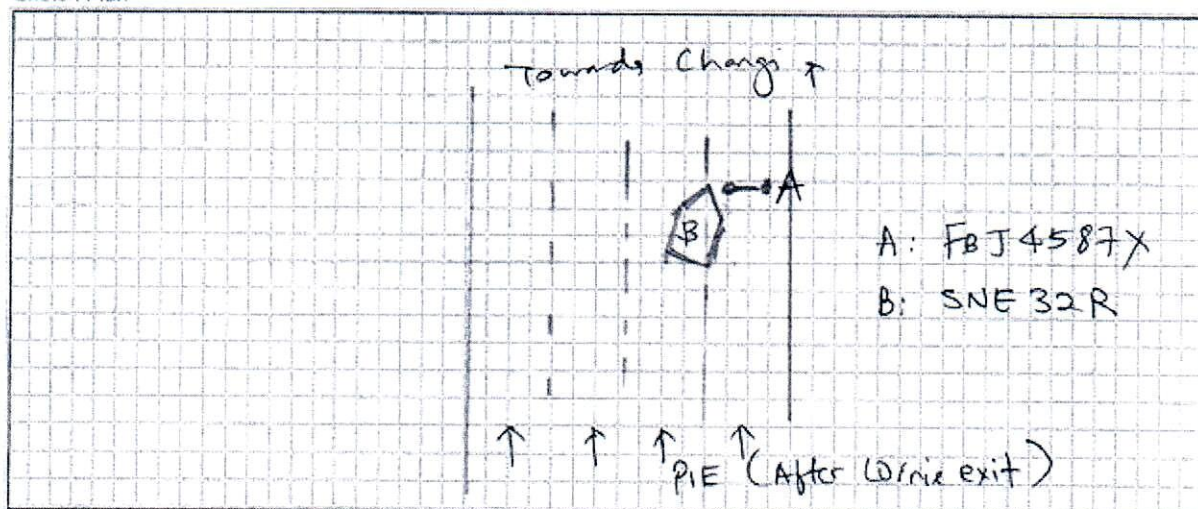

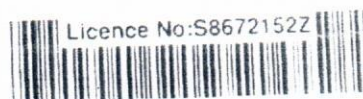
