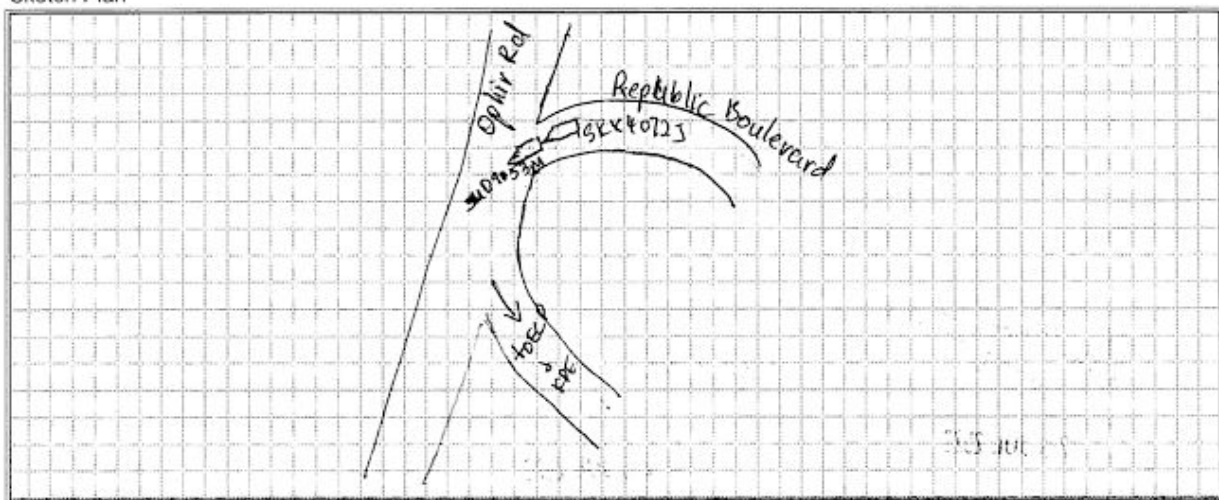

## Describe Circumstance of the Accident

I was driving along Republic Boulevard approaching Ophir Road behind SMD 9053M. We came to a stop to give way to traffic on Ophir Rd. When it was clear, SMD 9053M moved forward and I followed. Suddenly SMD 9053M braked and that's when the collision occurred.

I expected the car to stop for negotiations but it drove on. So I followed it to ECP and into KPE and it still did not stop. I lost track of it in the traffic.

I didn't make a report of the accident as

1. I did not want to claim insurance on my own car damage. I have repaired the minor damage and the total bill is \$1198.
2. My view is that it should be a 50/50 liability/fault due to the car braking. So each party should be responsible for its own damage/repair.
3. As SMD 9053M did not stop, I feel the car has the same opinion, that is, each be responsible for its own damage/repair.

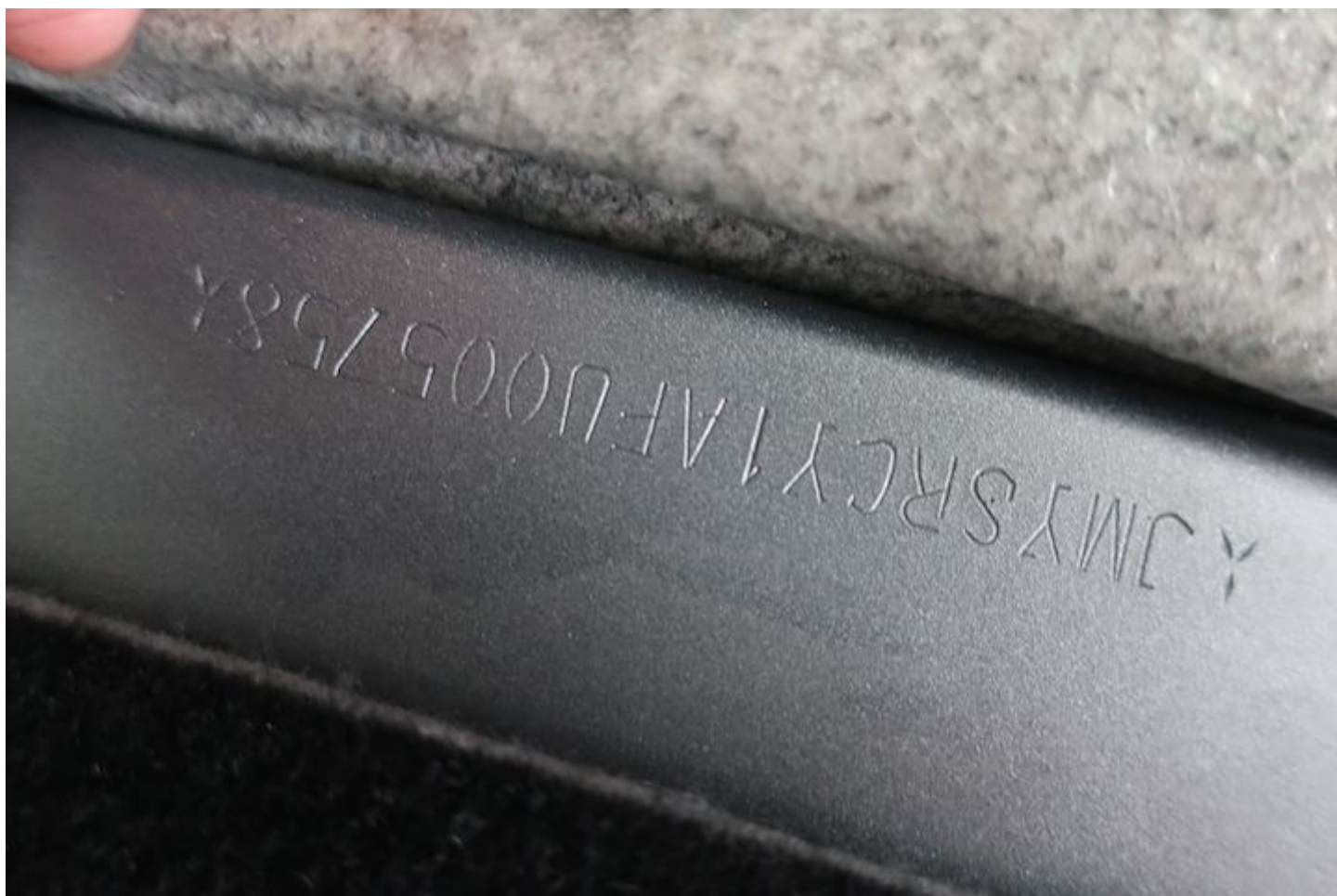
