Brief Details.

I was driving along the slip road from Republic Boulevard going into Ophir Road. I stopped to give way to traffic on Ophir Rd. When it was clear, the car in front of me moved and I followed. The car in front of me suddenly stopped. That was when the collision occurred.

I expected the front car to stop to exchange particulars, but it just drove on. So I followed, going up the ramp to ECP, all the way into KPE heading towards Tampines. It still did not stop. I lost track of the car in the traffic.

I did not make a report because:

- 1. There were no physical injuries. (I was told by the police that no report need to be made in such an accident). I also did not want to claim insurance on my own car damage.
- 2. I believe that this incident is a 50/50 liability/fault due to the car braking in front of me suddenly. As such, each party should be responsible for its own damage/repair.
- 3. As the front car did not stop, but kept driving, I believed that the driver felt the same, that is each party be responsible for its own repair.
- 4. I also could not remember the number of the other car exactly.

I wish to emphasize that this cannot be considered a hit and run by me. I wanted to stop, that was why I followed it, but the front vehicle did not stop but kept moving till I lost it in the traffic. If anything, the front vehicle should be considered the hit and run driver rather than I.
