



Describe Circumstance of the Accident




I was alone at the time of accident. The other vehicle had 01 passenger with the driver.

Brief Details.

ON 15.07.2022 AT AROUND 1105HRS, I WAS DRIVING MY MOTORCAR SLM4044L ALONG YISHUN AVE 7 TOWARDS SEMBAWANG ROAD. I STOPPED MY CAR AT THE SLIP ROAD TO SEMBAWANG ROAD TO CHECK FOR TRAFFIC CLEARANCE. AFTER A FEW SECONDS, A MILITARY TRUCK (22100MID) CAME FROM BEHIND AND RAMMED ONTO THE REAR OF MY VEHICLE. DUE TO THE STRONG IMPACT, MY VEHICLE WAS PUSHED OUT OF THE STOP LINE. MY VEHICLE SUSTAINED SERIOUS DAMAGES ON THE REAR PORTION.

I WAS ALONE AT THE TIME OF ACCIDENT. THE OTHER DRIVER HAD 1 PASSENGER ON HIS VEHICLE.
