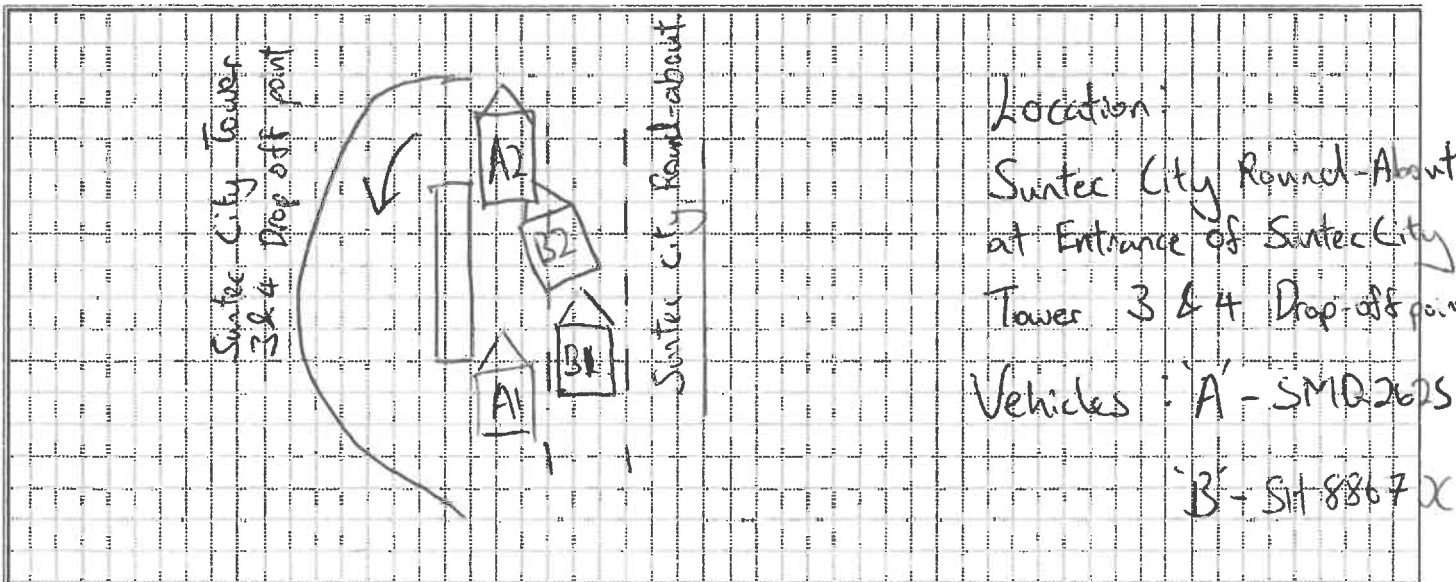

On the stated date and time, 1 vehicle plate bearing "SMQ 2625" was travelling straight on lane 3 of SUNTEC CITY ROUND-ABOUT.
