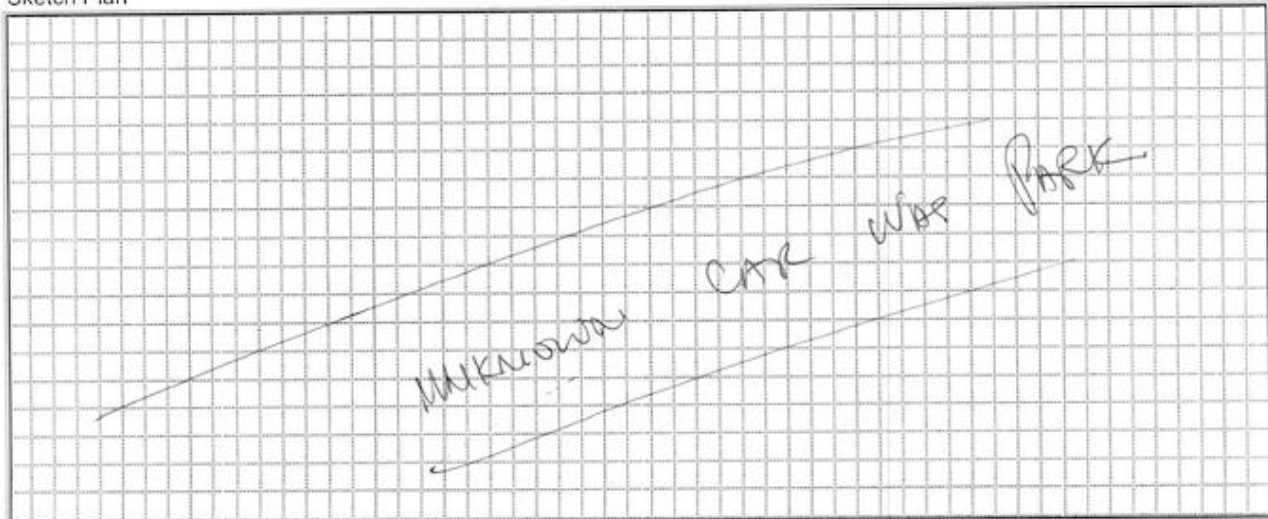

Describe Circumstance of the Accident

On 15/07/2022, at about 2:56pm, I, the owner and driver of ~~vehicle~~ vehicle no: SP21E, had walked towards my car, parked in Parkview Square, basement carpark lot number 7.

A man, Simon Tay, (NRIC: S1772098H), approached me and informed me that his vehicle no: GBE 4489X, was parked next to my ~~vehicle~~ vehicle in lot number 6. As he was driving out of his carpark lot, the mid left section of his vehicle had banged / collided into the front right portion of my vehicle. The impact had ~~resulted~~ caused ~~the~~ damage to the front right portion of my vehicle. The accident took place at about 2:30pm.

Simon Tay has confirmed he / his company will bear full cost, liability and responsibility for the damage caused and repair required. What's app correspondence ~~document~~ is available if needed as evidence.
