ON 16 JULY 2022, I WAS DRIVING TO MALAYSIA THROUGH THE TUAS CHECKPOINT. THERE WAS 4 PERSON IN MY VEHICLE. AFTER HAVING FILTERED TO THE LANE TOWARDS THE CHECKPOINT, THE CAR BESIDE ME DROVE VERY CLOSE TO ME, PRESUMABLY VERY UPSET UNTIL MY FILTERING. THE CAR WAS VW TOURAM SMY 9051 H AND WAS DRIVING INTENTIONALLY CLOSE TO MY RIGHT-HAND SIDE. THE CAR THEN SCRATCHED MY CAR ON THE RIGHT. WHEN I HEARD THE SCRATCHED NOISE, I STOPPED MY CAR. BY THE TIME, THE OTHER MIRROR WAS TOUCHING MY RIGHT-HAND SIDE MIRROR WINDOW. I LOWERED DOWN MY WINDOW TO ASK THE DRIVER TO RETRACT HIS SIDE MIRROR AND I WILL DO THE SAME SO THAT BOTH CARS MOVE ON. THE DRIVER REFUSED TO DO SO AND PROCEED TO DRIVE FORWARD. BY DOING SO, HE PUSHED MY RIGHT SIDE MIRROR FORWARD AND IT GOT DISPLACED. THE CAR DID NOT STOP AND DROVE FORWARD. BY THE TIME, I WAS DRIVING WITH A DISPLACED MIRROR AND A SCRATCHED CAR SIDE UNTIL I REACHED A PETROL KIOSK AFTER CUSTOM.

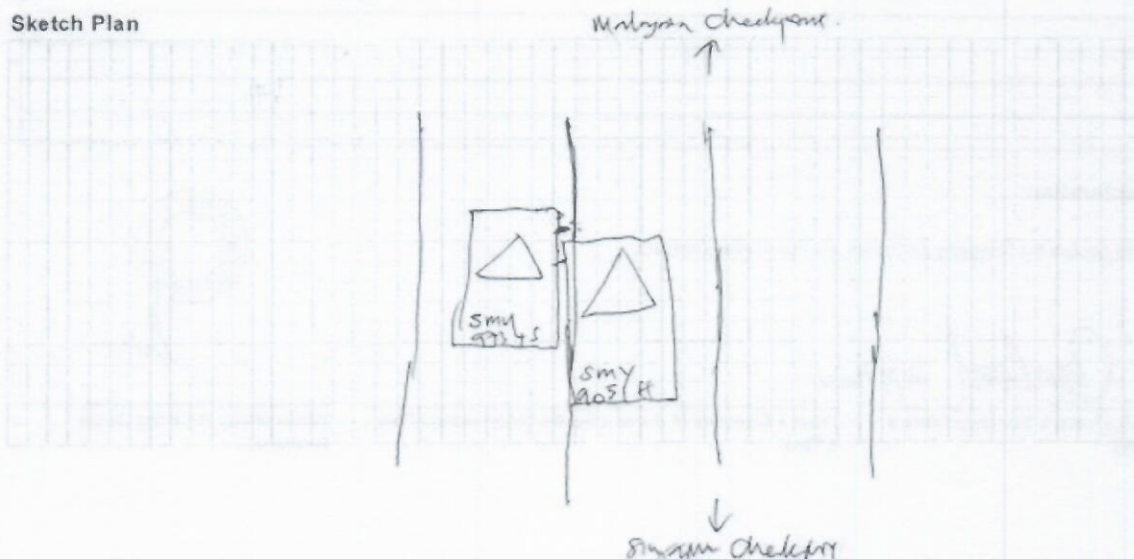
