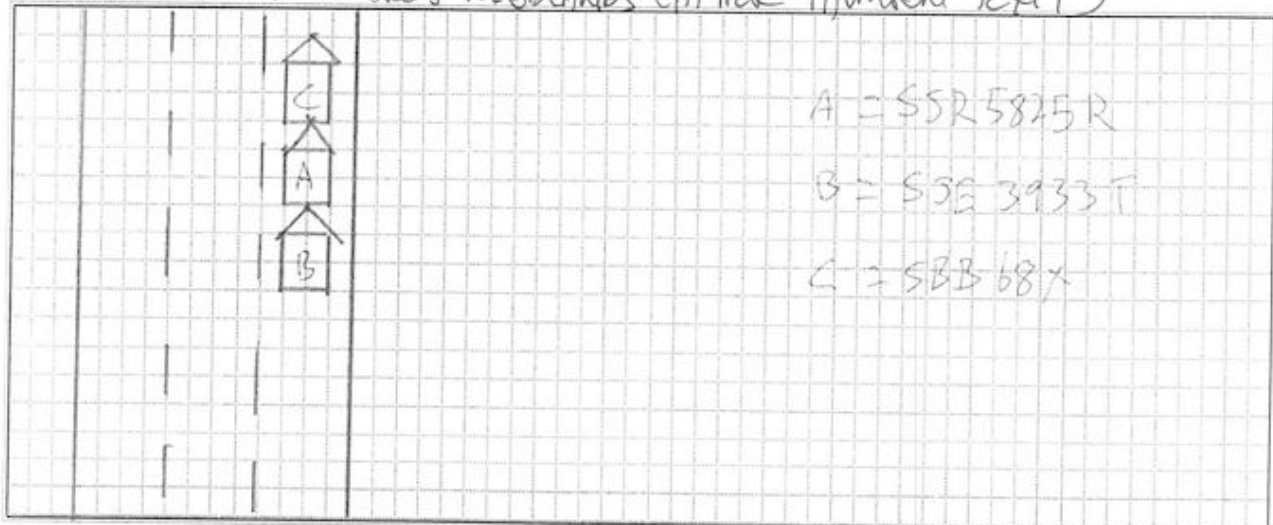

SLE Towards Woodlands (After 7th Avenue Exit)




## Describe Circumstance of the Accident
