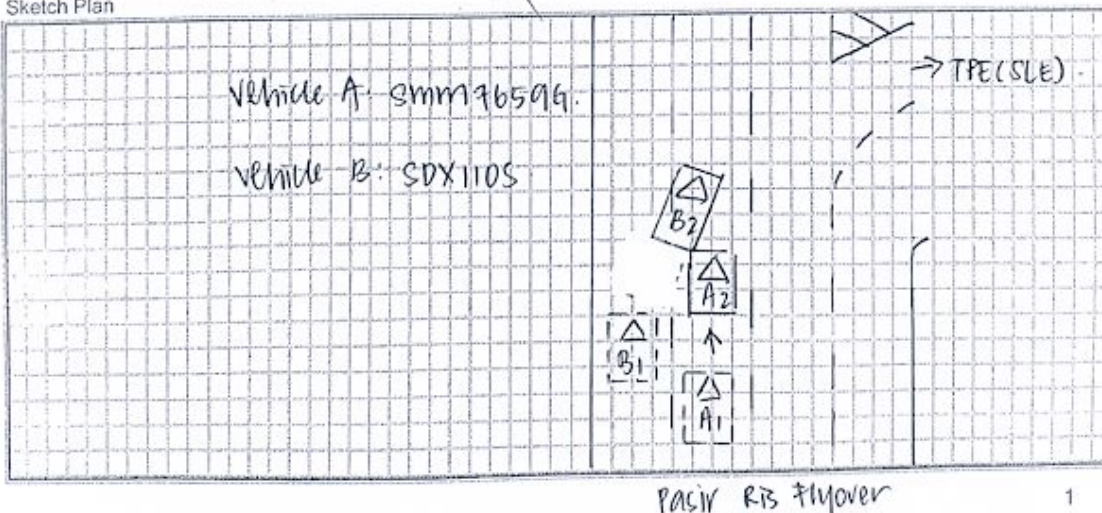

This Agreement is made on 29 July 2021 where rental period is from 30 July 2021 to 29 April 2022 between "JSphere Auto Services Pte. Ltd." (called the Lessor) and the Hirer(s) named in Rental Agreement and Schedule.

RENTAL AGREEMENT AND SCHEDULE

1. THE VEHICLE

Vehicle Make & Model: Toyota Prius Hybrid 1.8A, Vehicle Car Plate No.: SMM7659G, Vehicle Colour: Silver

2. HIRER(S) and AUTHORISED DRIVER(S)

Hirer: Ang Guo Bao, Identification No: S8506904G.

Address: Blk 126 Bedok North St 2, #12-74 Singapore 460126.

Hirer has taken over THE VEHICLE on 29 July 2021 at: 2300hrs at Mileage: 149647 KM and petrol level of 25% full.

3. RENTAL RATE/FEE

Hirer confirmed and agreed to pay JSphere Auto Services Pte. Ltd. Weekly rental fee of SGD\$420 on every Saturday. 1st payment due on 7th August 2021 is for the rental period from 30th July 2021 to 6th August 2021 at SGD\$420 per week.

Subsequent advance payments will be on every Friday. For avoidance of doubt, payment is always in pre-paid.

4. SECURITY DEPOSIT

A deposit of SGD\$400 is received. The full amount will be returned to Hirer on the date of vehicle return provided Hirer fulfils section 18 of the Terms and Condition upon return.

5. UNFULFILLED CONTRACT PERIOD

In the event the Hirer(s) could not fulfil the contracted renting period, the Hirer(s) will find a replacement hirer to fulfil the contract subject to Lessor's acceptance. In the event a replacement cannot be found, Hirer(s) is required to pay JSphere Auto Services Pte Ltd additional one-month rental fee on top of the month in rental. The security deposit will also be forfeited.

6. EXCESS LIABILITY AND ACCIDENTALS

Hirer(s) is required to pay the excess of SGD\$4,000 for Own Damage and/or SGD\$2,000 for Third Party claims. Where applicable, the excess of SGD\$4,000 applies on Own Damage claim and another SGD\$2,000 on Third Party Claims. (e.g. if claims happen for both own damage and third party, a total of SGD\$6,000 applies). Hirer must inform the Lessor immediately whenever an accidental occurs.

7. TERMS & CONDITIONS

Please refer to Terms & Conditions of this document. In the breach of the terms and conditions of the agreement, the Lessor reserves the right to resume possession of The Vehicle at any time from the Hirer in the Lessor's interest without prejudice. Lessor has the right to tow (repossess) the car back without Hirer's consent. Lessor will not be held accountable for loss of Hirer's items in The Vehicle. The security deposit will also be forfeited. Hirer must return the car key back to Lessor or pay \$500 for failure to return car key.

8. OTHER TERMS

- Late Payment fees will be applicable if rental fee is not in full paid 3 days after invoice is due. Late payment fees at \$: 1/day is in addition to the rental fee. Lessor has the right to tow (repossess) the car back if payment is not made 3 days after invoice due date. Lessor will not be held accountable for loss of items in The Vehicle.
- This Contract will continue to stay in force until Appendix - Return Form below is filled up.
- Hirer must inform the Lessor if there is an accident regardless of severity and settlement with 3rd party and must make an accident report with the Lessor's insurance provider of The Vehicle.

TERMS & CONDITIONS

JSPHERE AUTO SERVICES PTE. LTD. (hereinafter called "the Lessor" which expression shall where the context so admits include the Lessor's successors-in-title) hereby agrees to let and the hirer named herein (herein-after called "the Hirer") agrees to take on hire the motor vehicle described herein (hereinafter called "the said vehicle") subject to the following terms and conditions,

1. ONLY PERSONS ABOVE 24 AND BELOW 75 YEARS OF AGE WITH MORE THAN 2 YEARS DRIVING EXPERIENCE, AUTHORISED, LICENSED AND SIGNING THIS AGREEMENT MAY DRIVE THE VEHICLE
2. The said vehicle (and all tools and accessories therein) is the property of the Lessor and the Hirer shall be a mere bailee thereof and no interest in it shall pass on to the Hirer.
3. The hiring shall commence on the date and at the time specified and shall continue for the period and end on the date and at the time stated unless extended or as expressly requested by the Hirer.
4. Booking fee is strictly non-refundable. If for any reason the vehicle described in the schedule of any other vehicle ordered by the Hirer prior to the commencement of the period of hire is not available at the time of such commencement, the Lessor shall have the right to replace the said vehicle with an alternative vehicle of similar seating capacity and performance and if not such alternative vehicle is available then the Hirer shall be repaid any hire charge and deposit (if any) paid by Hirer after offsetting the rental charge and costs incurred but shall have no other claim of any kind whatsoever against the Lessor. However if no deposit is paid, the Hirer must pay for rental charges incurred on demand.
5. The Hirer shall pay in full the hire charge specified herein before the commencement of hiring. No part of such hire charge shall in any circumstances be refunded.
6. If the Hirer shall fail to return the said vehicle at the expiration of the period of hire, then without prejudice to the other rights of the Lessor, the Hirer, shall pay to the Lessor for every hour elapsing between the time of such expiration and the time the said vehicle is returned to the Lessor, such further charge in accordance with the Lessor's current rate of hire charges or at such other rates as the Lessor may in its absolute discretion think fit. All charges and amounts due which are not paid when due shall bear an interest of 1.5% per month until they are paid.
7. The said vehicle may only be driven by the Hirer or persons who are expressly designated and authorised therein (hereinafter called "the authorized driver") by the Lessor. The Hirer must seek permission from Lessor before allowing anyone else drive the car. The Hirer and the authorized driver must be in possession of a valid driving license and shall at all times drive the said vehicle in a careful and skillful manner, observing the traffic regulations and laws and in the event of any breach thereof, the Hirer shall pay all fines, cost of repairs and penalties which may be incurred and shall also answer all Police and Traffic Court Summonses, Notices and Inquiries in connections therewith. Particular attention is to be accorded to the following:
 - a. The Hirer shall not carry load or passengers in excess of the Motor Vehicle's Licensed carrying capacity (i.e. one driver and four passengers);
 - b. The Hirer shall not drive the said vehicle whilst under the influence of intoxicating liquor or drugs
 - c. It is expressly forbidden to give the said vehicle out to third persons or to let unauthorized persons or learners to use the said Vehicle or to permit the said vehicle to be used for illegal purposes (for instance: in connection with theft, drug pedaling or trafficking, smuggling, or any other criminal activity) or the purposes of test or racing. Failure to comply may entail serious consequences as the Hirer assumes full responsibility and in the event of the said vehicle being seized, confiscated or forfeited as a result thereof, the Hirer shall indemnify the Lessor for all losses incurred including the value of the said vehicle.
8. Use of vehicle for illegal purposes (e.g. in connection with theft, drug pedaling or trafficking, smuggling) is strictly prohibited.
9. The Hirer or authorized driver shall report all accidents involving the said vehicle to the Lessor immediately and should there be bodily injuries, police report to be made not later than 24 hours after the accident. The Hirer or authorized driver shall not admit or compound any claim either partially or in full. Hirer is to secure the names and addresses of all witnesses as well as the registration number of all vehicles involved in the accident. All communications or letters received from the police or third parties are to be referred to the Lessor immediately. The Hirer shall not abandon the said vehicle without adequate provisions for safeguarding and security the same time. Failure to comply with rules will render the Hirer liable for all costs and third party claims. The Lessor is not allowed to engage legal services to express any vehicle or personal injury claims. Lessor shall handle all vehicle and personal injury claims related to the accident.
10. The Lessor shall not under any circumstances be liable to make any payment to the Hirer in respect of or to indemnify the Hirer against any loss, injury or damage sustained by the Hirer or by any third party as a result of the use of the said vehicle the hirer shall be deemed to have satisfied himself that the vehicle is in good order and in a proper and safe condition.

11. The Hirer shall pay for the cost of petrol during the period of hiring PROVIDED ALWAYS that the Hirer having taken delivery of the said vehicle with petrol shall return it likewise, failing which the Lessor shall be entitled to refill the tank and the cost thereof shall be recoverable from the Hirer.
12. The said vehicle shall be covered under a Vehicle Insurance Policy which contains an excess Clause as Stipulated / Stated in the schedule above.
13. Due to negligence, Hirer agrees that punctured tyre(s), empty petrol tank, flat battery due to negligence, loss of vehicle's key or locked key inside the vehicle, by itself does not constitute a breakdown and that in the event the Lessor's 24 Hours Emergency Assistance is called upon to respond to such occurrence, the Hirer shall bear the full cost of such response. Punctured and damaged tyre(s) due to negligence that cannot be reused will be charged accordingly from S\$80-S\$200 per tyre.
14. Windscreen damage is covered by insurance with an excess fee (Please refer to insurance policy for excess fee). Windows damages are not covered under insurance, Hirer is required to pay for all damages to the windows.
15. All vehicles are supplied with petrol and should be returned with petrol level likewise. There will be no refund for excess petrol.
16. No refund of Security Deposit for early return of vehicle before end of rental period.
17. No smoking in the car. Transportation of durians and pets are allowed but there should not be any evidences upon the return of vehicle. Hirer is responsible for a penalty of S\$500 if there are evidences of smoking in car, smell of durian or pets.
18. On or prior to the expiration of the period of hire, the Hirer shall return the said vehicle together with all tools, accessories and equipment to the Lessor at a mutually agreed value in as good order and condition as the said vehicle excluding wear and tear when collected by the Hirer from the Lessor.
19. No relation, forbearance or indulgence by the Lessor in enforcing any of the terms and conditions of this agreement shall prejudice or affect the rights and powers of the Lessor hereunder nor shall any waiver or any breach operate as a waiver of any subsequent or continuing breach.
20. The Hirer is responsible for obtaining the required cash card with sufficient balance prior entry into any roads within the ERP system.
21. In the breach of the terms and conditions of the agreement, the Lessor reserves the right to resume possession of The Vehicle at any time from the Hirer in the Lessor's interest without prejudice. Lessor has the right to tow (repossess) the car back without Hirer's consent. Lessor will not be held accountable for loss of Hirer's items in The Vehicle. The security deposit will also be forfeited. Hirer must return the car key back to Lessor or pay \$500 for failure to return car key.
22. The Lessor shall not be liable to the Hirer or any person for any loss or damage whatsoever and howsoever caused or occasioned by reason of the Lessor resuming possession of the vehicle nor shall the Lessor be liable to any person for monies, good, articles or things not belonging to the Lessor which are or alleged to be in the vehicle at the time the Lessor resumes possession of the vehicle. A notice in any written forms (i.e. WhatsApp, SMS, etc.) will be issued to hirer at least 3 days before possession.
23. The Hirer shall not take the said vehicle outside mainland Singapore, without the written consent of the Lessor. Failure to comply with this term may entail serious consequences and the Hirer shall assume person and full responsibility and in the event of the said vehicle being damaged, seized, confiscated or forfeited as a result thereof. The Hirer shall indemnify the Lessor for all losses incurred including the value of the said vehicle.
24. That in addition, the Hirer shall be deemed to have extended the period of hire by reason of the Hirer's failure to return the said vehicle or continued possession and/or continued use of the said vehicle upon the same terms and conditions in respect of any replacement vehicle hired in lieu of the said vehicle by means of new Rental Agreement or Replacement Voucher.
25. No Refund Policy. No refund upon confirmation and payment of deposit for the booking.
26. Consumer Policy. We collect and store your personal information from you. Our primary goal in doing so is to provide an efficient and smooth communication with you. If requested by the laws of Singapore, we will disclose information to the government or third parties. We will seek your consent before we disclose your information to any bodies beyond the laws of Singapore and use of Jsphere Auto Services Pte Ltd.
27. Lessor has the right to re-negotiate the rental fee with Hirer(s) in the event LTA enforces the new ERP Charging system different from the current system as the version dated as of this document. Either party may terminate this contract if rental fee cannot be agreed without either party been notified.
28. Replacement vehicles are subject to availability. In the event a replacement vehicle is not available rental (daily) will not be charged if the vehicle is not operational and not due to negligence.
