   Please contact the rental car company (please refer to the rental car company listed below, hereinafter known as the "Rental Car Company") after AIG's authorised surveyor has surveyed and authorised the own damage repair of your accident vehicle.
   Your rental car will be made available within 5 working hours of you contacting the Rental Car Company.
- 4. At the time of collection of the rental car, the original insurance policy and schedule issued by AIG and a copy of the accident
- report from Audi Customor Service Centre must be produced.

  The rental period will be the shorter of (i) the repair period certified by AIG's-authorised surveyor or (ii) the period your accident vehicle is actually under repair (and not for any period during which your accident vehicle is not under repair due to the unavailability of spare parts).
