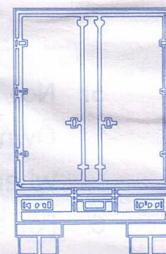
Left Side View

Terms and Conditions:

1. The Hirer shall bear full responsibility for all parking & traffic violations during the period the vehicle is on leasing/rental or loan.
2. The Hirer shall undertake to maintain the vehicle by daily checking of coolant, propellant, lubricant levels etc. Any consequential damages to the Vehicle resulting from the Hirer's failure in these undertakings shall be the Hirer's liability and the Hirer shall bear the cost of restoring the Vehicle to its original working condition.
3. The Hirer to pay for towing charge of S\$100.00 if break down of vehicle is due to failure of the hirer to top up of petrol/diesel, coolant.
4. The Hirer shall bear full responsibility for any property damages/injuries claims arising during the period of hire due to any one occurrence:-
 - (i) during the time of occurrence, the Vehicle was being driven by the Hirer or by any person on the order of or with the permission of the Hirer whilst under the influence of intoxicating liquor or drugs.
 - (ii) The driver of the Vehicle at the time of occurrence failed to file an official report regarding the details of the occurrence.
5. Not fit any accessories to or modify the Vehicle in any way without the previous consent of the Owner and prior to the expiry or termination hereof, not to remove any approved necessities where required Hirer is to reinstate Vehicle to its former condition at the cost of the Hirer.
6. For any reason the Owner deems it impracticable to repair any damage caused to the Vehicle (but not amounting to a total loss) the Owner shall have the right (but not obligation) to replace the Vehicle with an alternative vehicle of similar capacity.
7. The replacement of vehicle is provided should the Vehicle be required for mechanical repairs due to fair wear and tear or inspection by the Land Transport Authority. No replacement shall be provided in case of amage due to accidents or mechanical repair owing of the Hirers negligence in the use for purpose other than for which the Vehicle is designed.
8. To be responsible for the excess in the case where insurance claim is applicable.
