Third party reported that he was travelling straight on Dunbar Walk towards Coldstream Ave. Our lorry was stationary in front. Third party overtook our insured lorry after he checked the opposite traffic was cleared. After he passed by our insured lorry, suddenly he felt an huge impact and realised that insured cut out and hit his car.

Our insured driver reported that he was stationary and just as he moved off, third party left side collided onto our lorry right front side portion.

Third party has no video, only submitted scene photos for this matter.

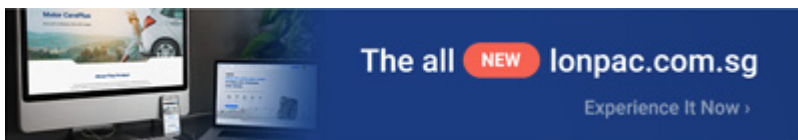
