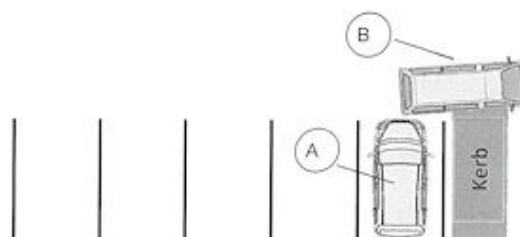
Sketch Plan

Brief Details.

Case of HIT AND RUN.

On 24 July 2022 at or about 6.30pm, I had parked my vehicle at the open carpark of Angullia Park near to Wheelock place. I had parked my vehicle, SKA7035T nearest to the exit of the carpark. Everything was intact when I left the vehicle.

At or about 9.17pm, I came back to my vehicle and discovered that there was scratches on front and right bumper. I further discovered that my plate casing and late number was broken and was underneath my vehicle. While checking my vehicle, I was approached by another driver, SLX7137A who told me that he had witnessed one black van, GBJ9445P had reverse and hit onto the front side of my vehicle.

I had checked my in-car camera and it captured the said van at or about 7pm, reversing from the carpark gantry and mounted the curb and hit onto the front part of my vehicle. The driver of the said vehicle was seen exiting his vehicle and pretended that nothing happened. He had continued by topping up his cashcard and that was the reason he had reverse due to insufficient balance. In addition, based from the footage, it appears that the driver of the said vehicle was believed to be intoxicated.
