

permission they enter my vehicle and shouted at me to drive off. I was unable to stop them from entering my vehicle because there was cars waiting behind my vehicle to turn out. I have no choice to just driver off as I don't want to obstruct the way of other vehicle. While out on Guillemard road on the left side of the road because I was turning left towards Geylang Lorong 22 where I live somewhere there. I was slowly down as I approaching the junction to "Turn Left and the drunken man obstruct me from turning left asking me to go straight and block my view and which I can't turn into my lane and i have to re-adjust as my vehicle was going a little bit right entering the next lane and the car on my right was turning to the left to hit my vehicle on my right side bumper . So I immediately stop and went down from my vehicle to check and the car owner of vehicle Smx1559t also went down then come the drunken man and her partner out from my vehicle and start fighting with the car owner of smx1559t.
