After the accident, Traffic Police and ambulance came down to the accident location. I was conveyed to Tan Tock Seng Hospital by ambulance. Doctor told me that I don't have any dislocation or fracture. I was given 3 days of medical certificate from 23/07/2022 to 25/07/2022 (3days). In this accident only the 2 said vehicles was involved and no other party involved.
