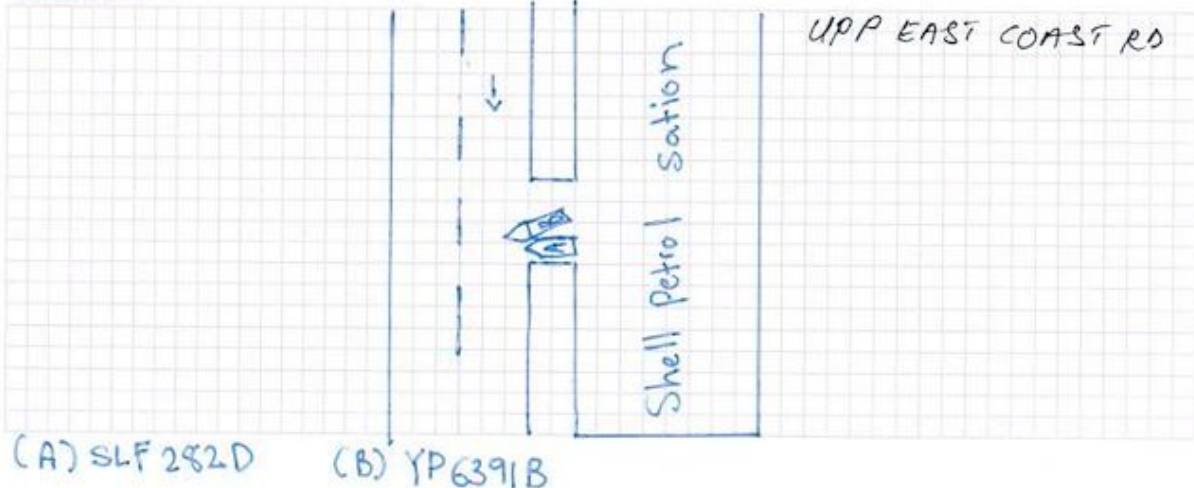


I wish to state that i was not moving my vehicle at all when vehicle B was turning
