I WAS TRAVELLING ON THE SECOND LANE OF A 4 LANE ROAD INTENDING TO TURN RIGHT. VEHICLE X CHANGED FROM LANE 1 INTO 2ND LANE ABRUBPTLY CAUSING VEHICLE A TO JAMMED BRAKE.
