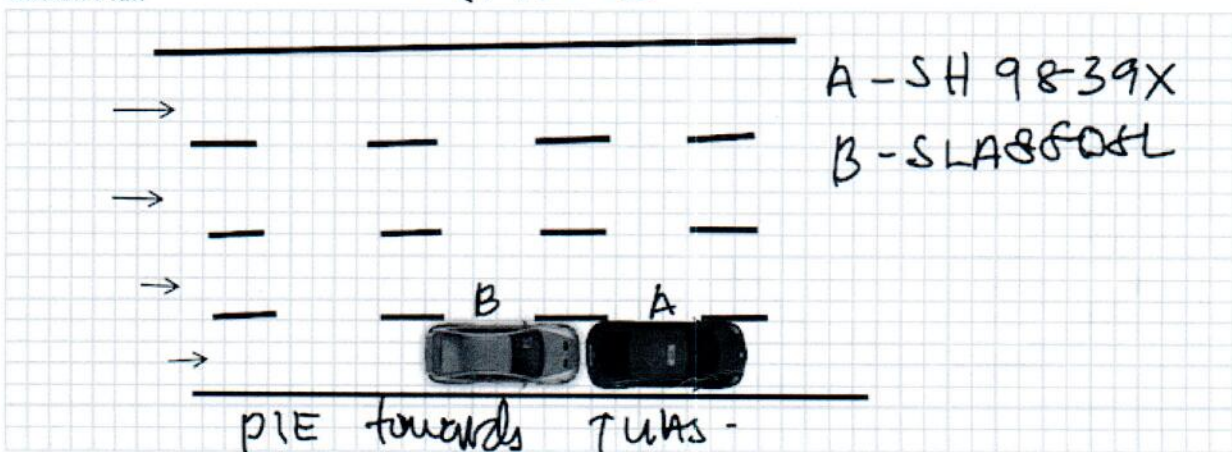

Sketch Plan

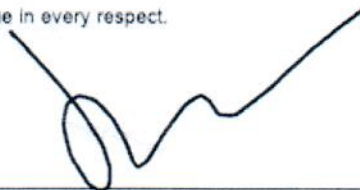


Describe Circumstances of the Accident
