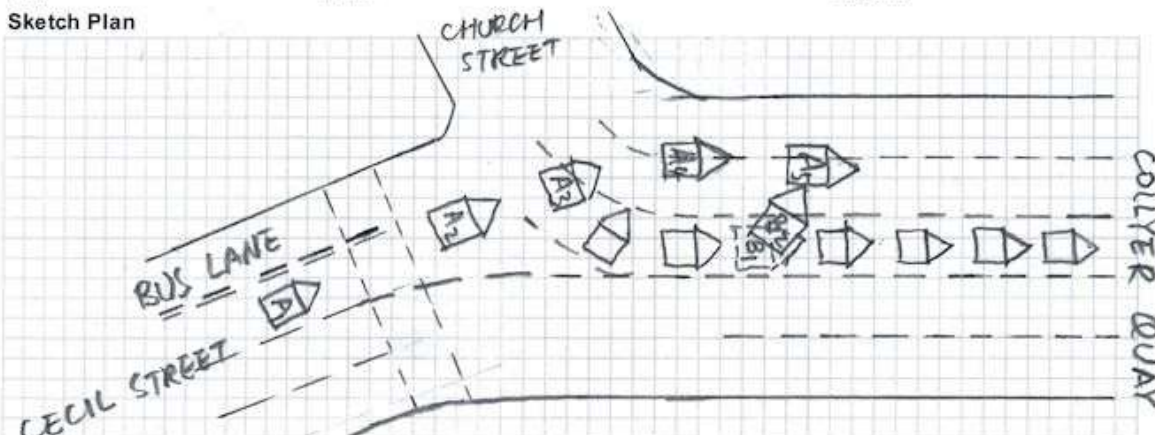

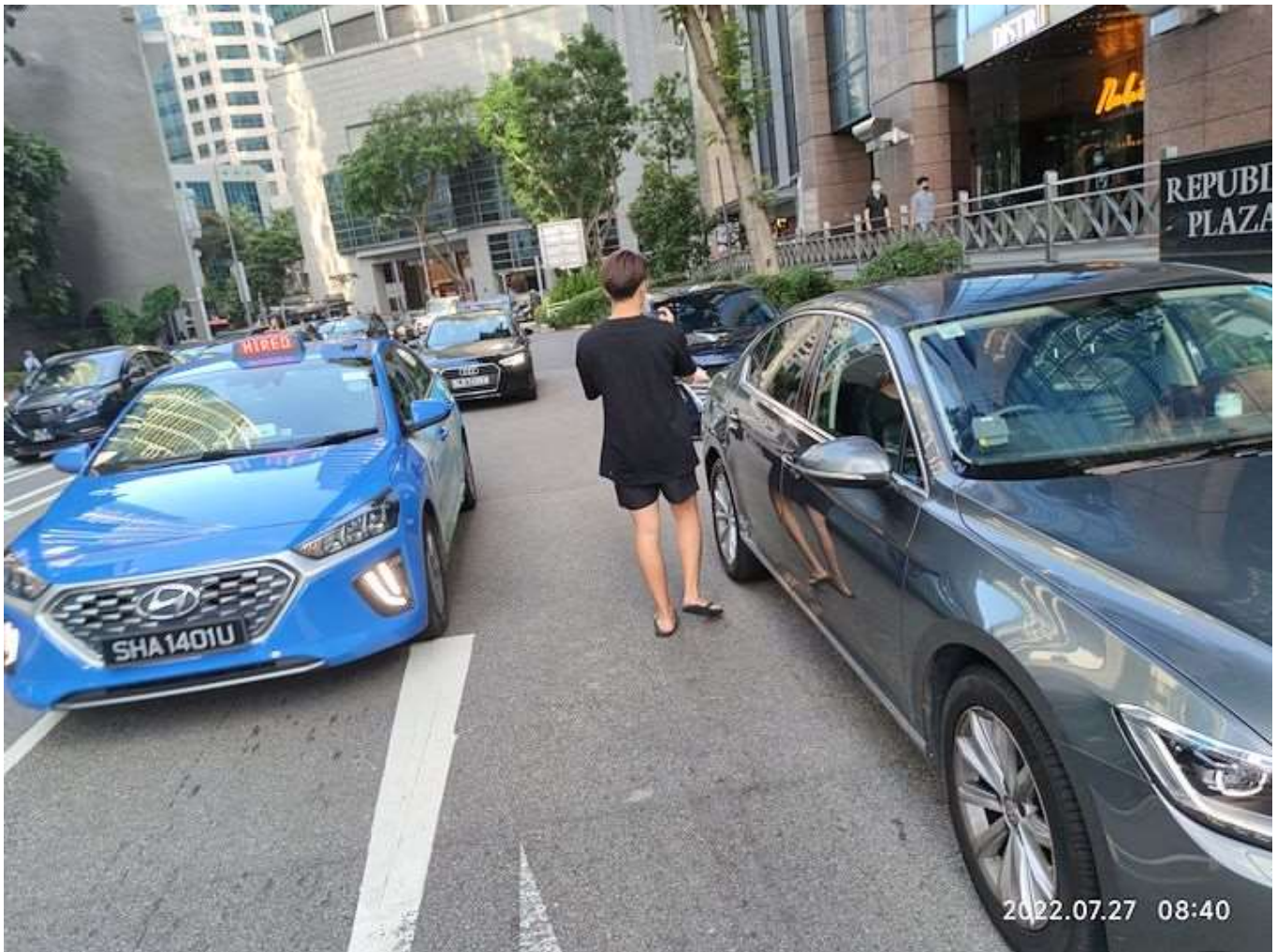
Accident Description

On 27 July 2022, around 08:35am, I was driving along Cecil street towards Collyer Quay direction in the second lane from left (first lane is bus lane). When I was passing through the traffic light at the cross with Church street, and continued to drive along the second lane from left side of Cecil street to the second lane from left side of Collyer Quay, a car was directly cutting from the fourth lane of Cecil street to the second lane. I honked once and it stopped before cutting into the second lane from left of Collyer Quay. I continued driving to the second lane from left side of Collyer Quay, but slightly to the left to avoid that car protruding from the right side. As such, when I was driving into the Collyer Quay, my car was about on the lane dividing line between the first lane and the second lane from left side of Collyer Quay. I honked another time to alert the cars stopped in the right row that my car was approaching from behind. I continued to drive forward until I heard a sound of collision from the rear side of my car. After that I managed to park my car to the left side of Collyer Quay, beside the Republic plaza, then I realized that a car SMU4180Y suddenly turning out from the row of parked cars at the right side and hit the right side back of my car.

P.S. there are four lanes in Cecil street before the cross with Church street, but 5 lanes in Collyer Quay, and a big right bend from Cecil street to Collyer Quay. The eye sight of the driver in the cars stopped near the tangent portion will be blocked by the cars behind and can't clearly see the approaching car from right behind directly.
