**Brief Details.**

On 29/01/2022 at around 0845hrs, I was riding my bicycle along Jalan Bahar. At that point of time, I was waiting at the traffic junction for the traffic light to turn green. I wish to add that there is no car in front of me at the traffic light and the traffic is fairly light.

When the lights turned green, I slowly moved off and I was cycling at the left side of the road, along the yellow line. Out of a sudden, a Silver Toyota Axio, bearing the registration number of SKZ741C, hit me from the rear. As a result, I fell towards my left onto the grass patch. The other cyclists on the road then attended to me before the driver of the said vehicle approached.

Soon after, the police and paramedics arrived to make a check on me as well. I wish to add that I sustained some light abrasion on my knee and elbow. I also told the paramedic that I will book my own X-ray in the future if I deemed it to be necessary as I felt some pain at my lower back currently.
