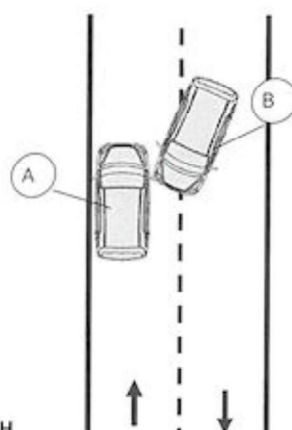
Sketch Plan

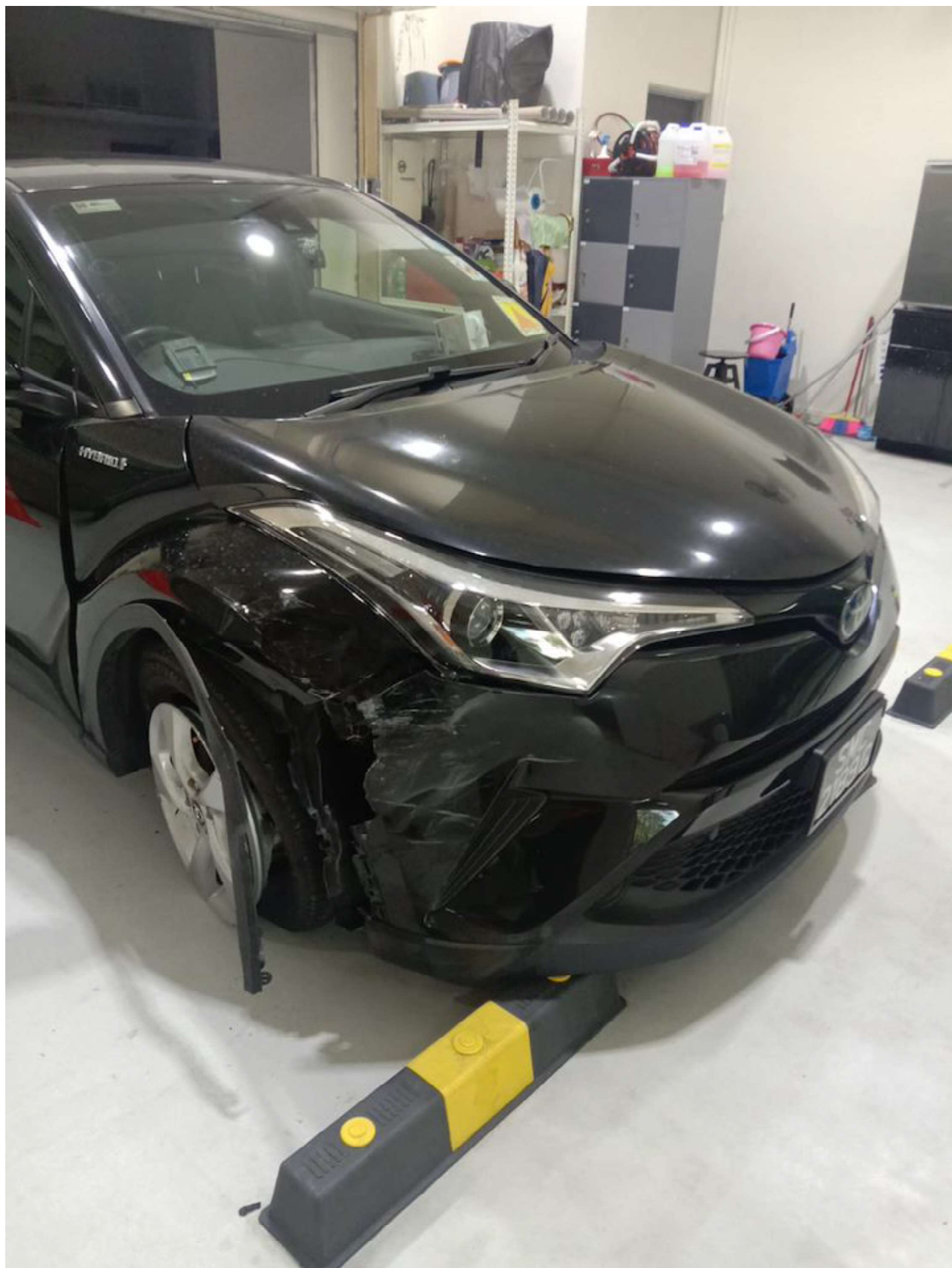
