




Sketch Plan




**Accident Report**

Between Van GBC1144Y and Car SLJ915R

On ~~Tuesday~~ <sup>Wednesday</sup>, 03 August 2022 at about 12.40pm

Coming out of the HDB Hub's carpark, I turned my car (SLJ915R) into Toa Payoh Lor. 6, and just before the traffic junction of Lor 2 and Lor 6, I filtered out to a loop road heading for PIE (towards Changi Airport). Before turning into PIE, I stopped at the junction because a car and an SBS bus coming from Thomson Road direction were passing by. As I stopped, a van (GBC1144Y) belonging to City Energy and driven by **Mr. Mohammad Noorhakim bin Mohamed Zin** (IC# S9423394A) hit my car from the back with a loud noise. There was a slight drizzle then and many vehicles were behind the van intending to turn into PIE too. Since no one was injured and in order not to hold up the traffic behind us, we moved our vehicles to the side of the road to allow the other vehicles to drive pass us and proceed on to PIE (towards Changi Airport).

Both Mohammad and I came out of our vehicles to inspect for damages. Mohammad apologised profusely to me and my passenger for crashing into the back of my car. He admitted that he was wrong and careless and was in a hurry to get to his destination after missing the turn into the second loop road that will lead him to PIE (going towards Thomson and Tuas).

On inspection, I noticed a little dent on the back bumper. On opening the car boot, I noticed that the alignment behind was slightly bent. I informed Mr. Mohammad that I will send my car to the workshop to check if there are any serious damages or not. Meanwhile, he told me that he will inform his company of the accident and file an accident report with his company's insurers.

We then exchanged driver's particulars and phone numbers and then proceeded on to our respective destinations.
