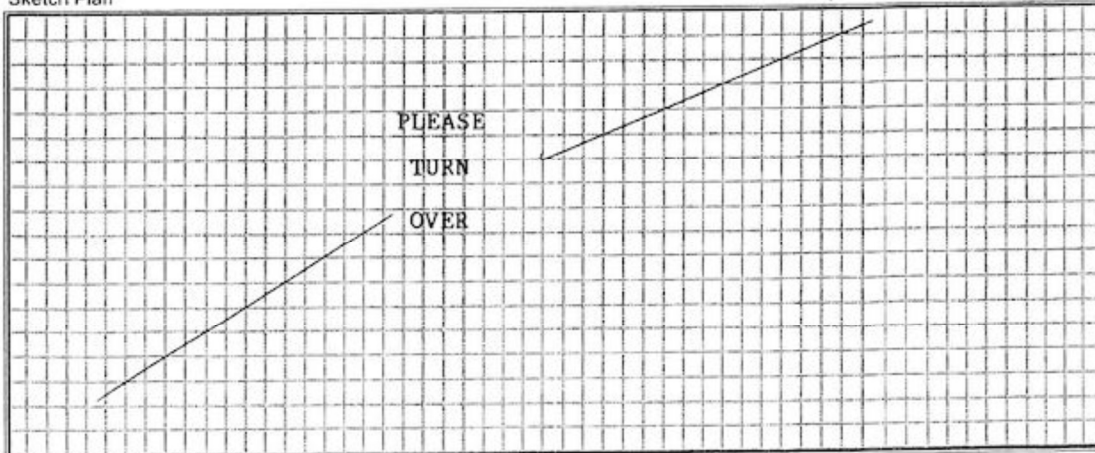

Sketch Plan




