



#### GENERAL DEFINITIONS

- (1) "WD" means WEIDA LOGISTICS AND SUPPLY, which include it's successors in-title and assigns.
- (2) "HIRER" freens the subcontractor & also the person(s) signing this agreement, any other person or entity to which the charges incurred under this agreement are to the billed, and any
  - "ADDITIONAL DRIVER" shown on the front page of this Agreement or otherwise to drive the vehicle with the written consent of WD.
- (3) "VEHICLE" means the motor vehicle or any substitute or replacement vehicle described in this Agreement and/ or other Form of Records, includes all tires, tools, accessories, equipment, keys, parts and vehicle documents in or on the vehicle.
  - THE TERMS AND CONDITIONS FOR THE RENTAL MENTIONED ON BOTH PAGES FORM AN INTEGRAL PART OF THIS VEHICLE RENTAL CONTRACT. BY SIGNING THIS CONTRACT, THE HIRER CONFIRMS HAVING READ THE TERMS AND CONDITIONS FOR RENTAL AND GIVING HIS/HER UNCONDITIONAL APPROVAL TO THE STIPULATIONS OF THE TERMS AND CONDITIONS FOR RENTAL.
- The HIRER acknowledges that the VEHICLE is the property of WD and that the VEHICLE is in perfect running condition. The HIRER is under
  obligation to return the VEHICLE together with all
  tires, tools, accessories and equipment on the prearranged date earlier if WD requests in as good order and condition as the VEHICLE was when collected by the HIRER from WD.
- Fuel is the HIRER's expenses. All VEHICLES are delivered with fuel and must be returned with the same amount of fuel as at the time of delivery. In
  the event the HIRER is unable to fill up the fuel for the VEHICLE, WD will be authorized to do so in his/her name and for the HIRER's account.
- The HIRER agrees to take proper care of the VEHICLE and to drive the same in a careful and skilful manner observing the traffic regulations and
  laws and in the event of any breach thereof, the HIRER shall pay all fines and penalties which may be incurred and shall also answer all Police and
  Traffic Court Summonses, including all notices and

inquiries in connection therewith, in particular the HIRER is to ensure that;

- VEHICLE must not be overloaded;
- b) At all times the VEHICLE must be provided with sufficient oil, water and the prescribed tire pressure;
- c) When not in use VEHICLE must be properly parked and locked.
- 4. The full rental cost calculated on the basis of the daily rental charge is payable on a WEEKLY basis starting from the date of delivery of the VEHICLE to the HIRER. At the expiration of this rental contract, i.e. when the VEHICLE is returned to the location indicated in this Contract, any additional rental charges, which may have been incurred, shall become due for immediate payment.
- The refundable deposit specifies by WD from time to time, is payable by the HIRER to WD on delivery of the VEHICLE. WD shall be entitled to deduct from the said deposit at its discretion and without notice to the HIRER any amount due or owed by the HIRER.
- 6. The HIRER shall use the VEHICLE with all reasonable care and shall not;
  - a) use or allow the use of the VEHICLE contrary to any law, rule or regulations in force in Singapore for any illegal purpose, or in any manner by which the VEHICLE might become liable to seizure, confiscation or forfeiture; or
  - b) carry passengers In excess of the limit for which the VEHICLE is licensed; or
  - c) carry passengers or property for reward; or
  - d) participate in any race test or contest or for any purpose other than a domestic one; or
  - a) use the VEHICLE for the purpose of giving driving lessons; or
  - f) use, operate or drive the VEHICLE under the influence of any intoxicating substance or liquid; or under the influence of any drug; or
  - do or allow or cause anything to be done, or omit to do, allow or cause anything to be done, whereby WD's Vehicle insurance policy shall no longer be effective.
- That the VEHICLE will be driven only by the HIRER and that the HIRER are duly qualified drivers of UBER/GRAB and above and hold current and valid licenses to drive the VEHICLE.
- The HIRER shall not take the VEHICLE outside the Republic of Singapore and shall keep the VEHICLE at all times in his possession and custody and
  not part with its possession or custody to any other person. If for any reason, the VEHICLE is taken out of Singapore without the prior permission
  or written consent of WD, the RENTAL shall be held liable and fully responsible for all cost and expenses including but not limited to damages,
  repairs, towing fee, fine and claims of any nature.
- 9. The VEHICLE is NOT covered by a policy of insurance covering PERSONAL injuries to or death of the HIRER or his/her driver. If the HIRER does not arrange any PERSONAL ACCIDENT insurance cover, WD shall not under circumstances be liable to make any payment to the HIRER in respect of or to indemnify the HIRER against any loss. Injury or damage sustained by the HIRER arising out of the use of the VEHICLE or as a result of any defect therein. Upon taking delivery of the VEHICLE, the HIRER shall be deemed to have satisfied him/herself that it is in all respects road worthy had in a proper and safe condition.
- 10. The VEHICLE is insured under a standard motor vehicle insurance policy in accordance with laws of Singapore. The HIRER agrees to be bound by the terms and conditions of the said policy, a copy of which is available for inspection. The HIRER agrees to protect the interest of WD and the insurance company in the event of accident by;
  - a) Obtaining names and addresses of all parties involved and of witnesses and not admitting liability or guilt without advance notice to WD;

- Not abandoning the VEHICLE without adequate provisions for safeguarding and securing same;
- Giving detailed report including diagram even in cases of slight damage within 24 hours at the nearest police station;
- Notifying WD's insurers immediately of such accidents and submitting a duly completed Motor Accident Report Form;
- e) Delivering to WD all correspondence, Writ or documents of any kind received by the HIRER relating to any accident involving the VEHICLE while rented under the Agreement;
- f) Comply with all requests by WD to provide assistance in any litigation or investigation of such accident;
- g) Bearing the full compensation and repair payable to WD for any loss or damage to the vehicle during the hirer period and additional charges for loss earning to the company while damaged vehicle is under repair if there is an accident that results in any Third-Party claim and Company Third Party insurance is revoked, the hirer is responsible to pay the Company an excess of \$3000.00.
- 11. The HIRER expressly agrees to pay WD on demand all time, minimum or other charges applicable to this rental at rates or in the amount specified herein and in the current tariff published by WD and in addition, a sum equal in the amount or cost off all loss and damage to or in connection with the said VEHICLE during the rental period. The HIRER hereby assigns to WD any and all damage and insurance claims, which he/she may have in this connection and agrees that the same be paid directly to WD.
- 12. WD cannot be held responsible for any damages, not covered by insurance, to the HIRER and any third party in connection with the operation and the rented VEHICLE as well as the loss or damage to articles stored or left in the VEHICLE during the rental period. The HIRER agrees to exonerate WD from all responsibility in connection with any loss or damage or inconvenience caused by the belated delivery of the VEHICLE to the HIRER, possible motor troubles or any other causes.
- The person(s) signing the Contract assumes full personal responsibility, jointly and severally with the firm, person or organization, the driver or all substitute drivers in whose name he/she or they might sign.
- 14. Arising out of any breach by the HIRER or any of the terms and conditions of this Agreement;
  - a) The HIRER shall pay WD on demand all losses and damages suffered by WD arising out of breach by the HIRER of any terms and conditions of this Agreement including, but not limited to any loss or damage suffered by WD from WD's loss of use or loss of the VEHICLE for any reason whatspever.
  - b) The HIRER shall pay on demand all costs and expenses (including legal costs on a solicitor and client basis) incurred by or on behalf of WD for taking any legal proceedings to enforce the provisions of this Agreement.
  - c) The HIRER shall at all times indemnify and keep indemnified WD and shall save and keep WD harmless against all losses, damages, claims, penalties, liabilities and expenses including legal costs however arising or incurred by WD.
- 15. PROVIDED HOWEVER, the VEHICLE is operated by the HIRER in accordance with all the terms and conditions of this rental.

If the VEHICLE is not returned to WD on the due date as stated in the front page hereof or if the HIRER is in breach of any of the terms of this Agreement, WD shall be entitled to repossess the VEHICLE at the HIRER's expenses at any time without giving him/her prior notice and the HIRER hereby irrevocably authorize WD, its servants or agents to enter into and unto any premises in which the VEHICLE may be in order to repossess the same without being liable to any actions or proceedings at the suit of the HIRER or any persons claiming under through him/her.

- The RENTER is responsible for Electronic Road Pricing fees during the operative hours.
- The parties agree that they each have a material commercial interest in continuing close association with Uber B.V. ("Uber") via collaboration and direct contractual relations. In light of this,
  - a) In the event that in any single (non-consecutive) week of the rental period, the (HIRER) completes fewer than 50 (fifty) trips pursuant to booking for transportation services through the Uber App made by registered users of the Uber App and accepted by the Hirer through the Uber App (the "Uber Trips"), the Hirer shall, in additional to the Rental Fee pay a fee of \$100 for that week and the following week under this Agreement (the "Additional Rental Fee"). Notice in writing.
  - b) In the event that the Hirer for two (2) consecutive weeks does not complete at least forty five (45) Uber Trips per week(averaged), the (Owner) may, as well as seeking the Rental Fee and any additional Rental Fee for any week(s) driving below fifty (50) Uber Trips, immediately terminate this Agreement by giving the Hirer not less than (3) days' notice in writing.
- No relaxation, forbearance or includence by WD in enforcing any of the terms and conditions of this Agreement shall prejudice or affect the rights and powers of WD.
- 19. This agreement and VEHICLE cannot be assigned or transferred by HIRER. The HIRER remains responsible regardless of any attempted assignment.
- 20. This agreement shall be governed by and is construed in accordance with the laws of Republic of Singapore.
