Due to heavy traffic, vehicles ahead of me slowed down, came to a stationary position & I followed suit. Driver of vehicle B claimed that she had tried to avoid a collision by swerving towards left but failed.

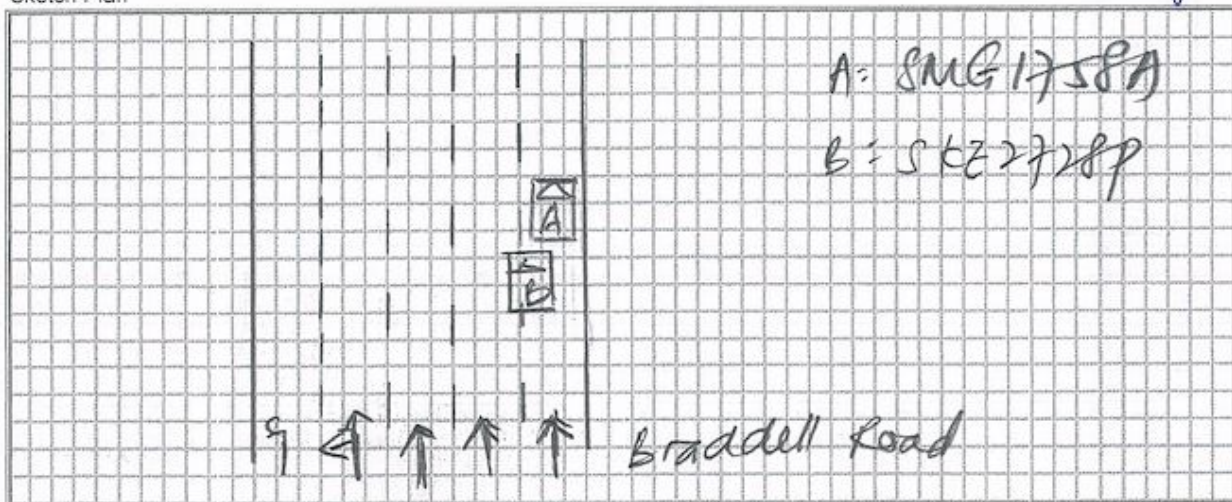
