We referred to your email dd11.11.2022, we found out there was no offer for the towing.

Our client's vehicle was unable to drive due to the rim damage in the scene after the accident hence needed the towing service.

Accident happened on **Friday 12.08.2022 @ 1935hrs** and all the ARC was closed hence vehicle towed back to our workshop first and the owner came to our workshop on **next Monday 15.08.2022** for the accident report due he injured and seek medical treatment on **Friday 12.08.2022** after the accident thus **Saturday 13.08.2022** he unable came over our workshop for the accident report. Refer attached MC and receipt.

Then the vehicle was towed to ARC [**Progressive Car Care Pte Ltd @ Ubi**] on **Monday 15.11.2022** to take photos for accident report submission hence 2 trips towing fees applied.

Enclosed wheel alignment after repair of the vehicle for your reference.

We would like to appeal the loss of rental as 10 days, vehicle taken on Saturday 13.08.2022 and your good Surveyor Adrian only came on Monday 15.08.2022 for the survey and given 6 working days for the repair.

Our counter proposal as follows:-

Cost of Repair : \$ 9,416.00 (\$8,800 + 7% gst)

Loss of Rental : \$ 1,800.00 (\$180 x 10 days)

Towing Fees : \$ 120.00 **[9101 Scene to our workshop]**

Towing Fees : \$ 180.00 **[9105 Our workshop to ARC]**

LTA Search : \$ 2.00

Total : \$ 11,518.00
