I have referred to the following documents as a background:

Mr Pek is a 41 year-old man, who works as a lorry crane driver. He has no previous medical problems or accident injuries of note. He is right handed.

He was involved in a road traffic accident on 23 January 2021 at 2237H at night. He was riding his motorcycle and was going straight, when he was knocked down by a turning taxi from the opposite direction. He was hit on the right side, and fell onto his left side.

Subsequently, he was sent by the SCDF Ambulance to Khoo Teck Puat Hospital (KTPH). According to Mr Pek, he sustained multiple abrasions to the left shoulder, left elbow, left hand, left knee and right leg. He also had left little and ring fingers pain.

At KTPH, he underwent X rays of the left hand, chest, and pelvis. No fractures were seen on X ray. He was given pain medication, and medical leave was given from 23 January 2021 till 29 January 2021.

He was then referred to Bukit Batok Polyclinic for wound dressings, and his medical leave was extended from 30 January 2021 till 9 February 2021.

I reviewed Mr Pek on 8 February 2021. His condition was as follows:

1. Multiple healing abrasions of the left shoulder, left elbow, left hand, left knee and right leg.

- 2. Left hand: There was no more pain in the left little finger, but he still had pain in the left ring finger middle and distal phalanges. Pain score was 5/10.
- 3. He also complained of left sided chest pain 1 week after the accident. Pain (pain score 6/10) mostly occurred when he was bending to his left side. There was also discomfort on deep breathing (pain score 2/10).

On examination:

1. Mr Pek was alert and had a stable gait.

2. Abrasions:

- a. Left shoulder: 5cm diameter abrasion associated with tenderness of the left shoulder superiorly.
- b. Left elbow: 3cm x 1cm healing abrasion.
- c. Left hand: 3 x healing abrasions over the left hand dorsum (1cm diameter x 2, 2cm diameter x 1); left little finger dorsum 1cm diameter abrasion; left ring finger distal dorsal 2cm x 1cm healing abrasion.
- d. Left knee: 3 x 1cm diameter abrasions.
- e. Right leg: 2 x 2cm diameter healing abrasions.

3. Left shoulder:

- a. There was left trapezial tenderness with no spasm, and left acromial region tenderness
- b. There was no impingement syndrome.
- c. Range of motion was preserved.
- d. Left supraspinatus power was about 4+/5. Infraspinatus and subscapularis power was preserved.
- 4. Left elbow: There was full range of motion with minimal tenderness.

5. Left hand:

- a. He had tenderness of the left ring finger middle and distal phalanges, and stiffness of the left ring finger distal interphalangeal joint (DIPJ), limiting a full grip.
- b. Left ring finger DIPJ was stable, with active flexion and extension preserved.
- c. Power was not assessed at this time because of his pain.
- 6. Chest: There was tenderness of the left lower ribs, but there was no bruising or crepitus.
- 7. There was no left knee /right leg tenderness.
- 8. CT scan of the thorax and left hand on 8 February 2021 did not reveal any fractures in the chest or left hand.

Diagnoses of injuries:

Mr Pek sustained the following injuries during this accident:

- 1. Multiple abrasions of the left shoulder, left elbow, left hand, left knee and right leg. These were healing at the time of my review.
- 2. Left shoulder contusion.
- 3. Left hand contusion.
- 4. Left chest contusion.

Treatment and Progress:

Treatment was as follows:

- 1. I gave Mr Pek 21 days of medical leave for rest (from 08 February 2021 to 28 February 2021 inclusive).
- 2. He was also referred for physiotherapy.

Review on 22 February 2021 showed that he was recovering well. He had undergone 1 session of physiotherapy. He had no more chest pain and he could make a full grip with the left hand.

I certified him fit to return to work after 28 February 2021, and gave him an open date for review. I also asked him to complete his physiotherapy session the same week.

He has not suffered any permanent disability of note, and does not require any further treatment at the present time. He can continue his current occupation.

In making this report, I affirm that the facts stated in my report are within my knowledge, which I have made clear and believe them to be correct at the time of the writing of this report. The opinions expressed represent my accurate and complete professional opinion.

Non-contrast CT scan of the thorax was performed. There are no comparison studies.

The axillary, supraclavicular, mediastinal and hilar lymph nodes are not enlarged.

The central airways are patent. Mild atelectasis is seen in the lung bases. No definite pulmonary nodule, groundglass density or consolidation is seen. There is no pneumothorax or pleural effusion.

The heart is not enlarged. There is no pericardial effusion. No mediastinal haematoma is seen.

A small 0.3 cm calculus is seen in the right proximal ureter at the level of L3 (Se6/497). There is no hydronephrosis.

There is no rib or sternal fracture seen. There is no fracture seen in the imaged spine.

No destructive bony lesion is seen.

COMMENTS:

No rib fracture seen.

Incidental finding of a small 0.3 cm calculus in the right proximal ureter. There is no hydronephrosis.

CT LEFT HAND

Non-contrast CT scan of the left hand was performed. There are no comparison studies.

No fracture or dislocation is seen, including in the left ring finger of concern.

A 0.6 x 0.2 cm exostosis is seen arising from the proximal shaft of the proximal phalanx of the left ring finger (Se5/319, Se9/9).
