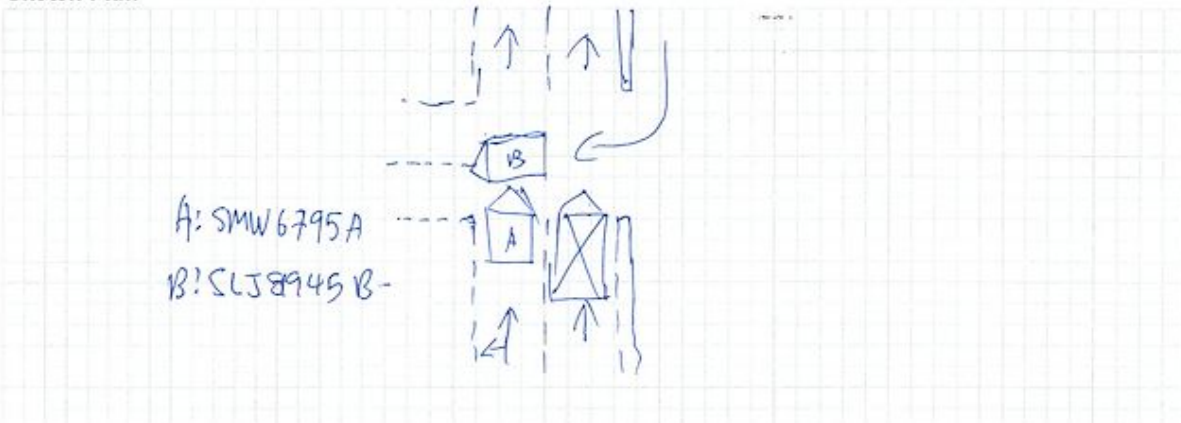

Sketch Plan


