**Brief Details.**

On 03/08/2022, at around 2100hrs, I was driving a CNB operational vehicle, bearing registration plate number SLL9153C at the point in time, along with officers SI Huang Weilun, INSP Joie and VSC Edwin Koh. We were conducting a follow-up operation to raid the official residence of an arrested subject, located at 777 Woodlands Crescent, whom my party of officers had arrested earlier in the evening at the vicinity of ToastBox of Plaza Singapura. At the material time, I was driving along Gambas Avenue, in which I filtered to the left most lane to enter the slip road to travel along Woodlands Avenue 9.

After passing the pedestrian crossing of the slip road, I stopped at the filter line as I saw motorcycles and a bus that was travelling from right to left and that they had the right of way. While the vehicle was stationary and I was checking to see if the lane was cleared of vehicles for me to drive off, I suddenly felt the vehicle jerked forward. That was when I realised that the vehicle had been hit from behind by another vehicle (SMF 1027G). I then proceeded to turn on the hazard light, and alighted from the vehicle, along with my other officers inside the vehicle.

Upon alighting from the vehicle, I noticed a White Mercedes, bearing registration plate number SMF1027G, that was right behind our vehicle. A male chinese subject was by the vehicle and inspecting the damage. I then checked on the damage done to our vehicle, in which i noticed visible damage done to the rear bumper of our vehicle. I looked at the White Mercedes and noticed visible damage to the front bumper. I then enquired on the driver of the white Mercedes if he was alright and okay, in which he replied that he was fine. My officer then took down his particulars whereas I contacted my office for the

next course of action for the vehicle.

We then explained to the driver that our vehicle was a government vehicle, and that we will need to make a police report to document down the incident, in which he acknowledged. After taking a few photographs of the vehicles, by us and the driver of the white Mercedes, the White Mercedes then drove off while we then drove to the nearby double yellow line ahead and stopped the vehicle while waiting for the tow truck to arrive to tow away the vehicle. The tow truck then came at around 2212hrs, and subsequently towed away our vehicle for their follow-up repairs. I wish to add that there is an in car camera with SD card.
