SKETCH PLAN

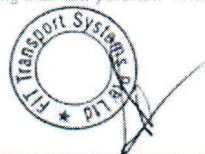

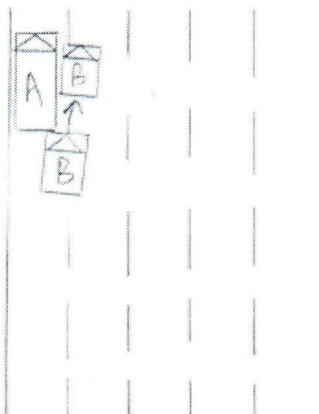

TUNNEL



Accident during MCE tunnel work authorised by LTA, Contractor Mr Lin Jin Peng driving Truck Mounted Attenuator (TMA) Number XD 2975T executing preventive maintenance work inside MCE tunnel, require to move from point to point. Tunnel lane usage display have put up as lane closed do not use the lane by LTA tunnel operators. Mr Lin Jin Peng saw a vehicle from his side mirror did not slow down, he then applied air horn to warn the driver about 12.08am, the vehicle continued in the lane reaching into the TMA deployed in front of the workers carrying out the work.

The driver of vehicle GBD858Y Mr RAJAN released it at the nick of time and attempted to leave the lane
