Brief Details.

On 10/08/2021 at about 0654hrs, I was driving my car bearing vehicle number (SJK3027C) along TPE towards SLE Woodlands. There was a Van, Toyota Hiace bearing vehicle number (GBK6922T), dark grey in color was speeding at a high speed on lane 1 signaling left towards Lentor/Yishun exit and a White Mercedes CLA180 was chasing the Toyota Hiace.

The Hiace left signal is on throughout. Inside the Hiace, there were blue flashing LED light.

As I was driving on lane 2 next to a Toyota lorry bearing vehicle number (GBE3755K), the Hiace van

accelerated and did a dangerous right overtaking of the Toyota lorry and the Hiace Van almost hitting onto the Toyota lorry. As a result of it, the Toyota lorry swerve to the right and suddenly came to the lane that I was travelling on and hit onto my car rear tyre at a speed of 90Km/Hr.

The Hiace van and the Toyota lorry did not stop and sped off. I then subsequently stopped my vehicle at the road shoulder.

On 10/08/2022, I went to Sin Min Clinic to consult doctor as I have stiff neck, head concussion and jaw lock after the incident. I was then given 04 days of MC from 10/08/2021 to 13/08/2021.

One week later, my right wrist sustained pain and numbness due to the accident and I have consulted a specialist doctor from Tan Tock Seng Hospital and I was informed by the doctor that I might need to get a surgery regarding about this.

I have previously also lodge 02 traffic accident report with ref T/20210810/2046 and T/20210810/2008.

I am lodging this report as my lawyer informed that the Hiace Van vehicle number was not added into the previous report.
