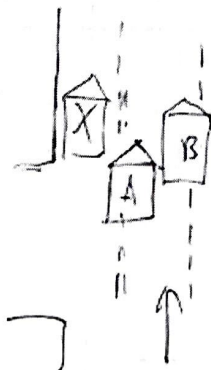
Sketch Plan




