ON 24/08/2022 @ 0020HRS, I WAS DRIVING MY VEHICLE A (SLV8538E) ON LANE 1 ALONG CTE TOWARDS AYE (AFTER HAVELOCK RD EXIT). CONSTRUCTION WORKS BLOCKED LANE 2 AND 3 AND VEHICLES IN FRONT OF MY VEHICLE A (SLV8538E) SLOWED DOWN AND SUDDENLY I FELT A HUGE IMPACT FROM THE REAR OF MY VEHICLE A (SLV8538E).
