
SKETCH PLAN

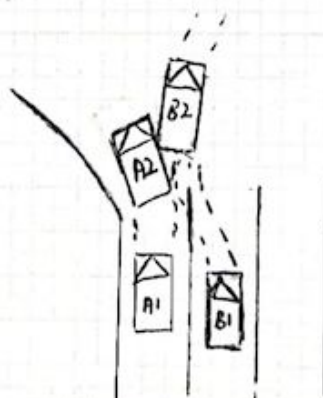


