

Describe Circumstance of the Accident

On 22/8/22 at around 7.45 pm, I was travelling along Honggang Ave 3 and was making a U-turn near Zi Yun Kai Ji Gong Temple. In front of me, there is a BRAB car that was also doing the same U-Turn.

After the U-Turn, the BRAB car came to a stop suddenly in front of the temple (possibly to search for his passenger's location). On seeing him stopping his car, I then checked for any incoming traffic and seeing that it is clear, I signalled and move out of that lane.

When I was fully in the middle lane, vehicle SNC 7592E crashed into the back of my car. We exit the car and we note that his front left is badly damaged.

While in a shock, the other driver insisted to have my SD card which I provided without hesitation. It was meant to transfer to his phone. However he just took it with returning me.

On second thought, I could not understand why he asked and took away my SD card. I wonder why his car is so badly damaged while mine has slight damage to the bumper.

I would like to submit a claim against him and to put on record that I'm concerned he may doctor the footage from my SD card for his advantage. That's all.
