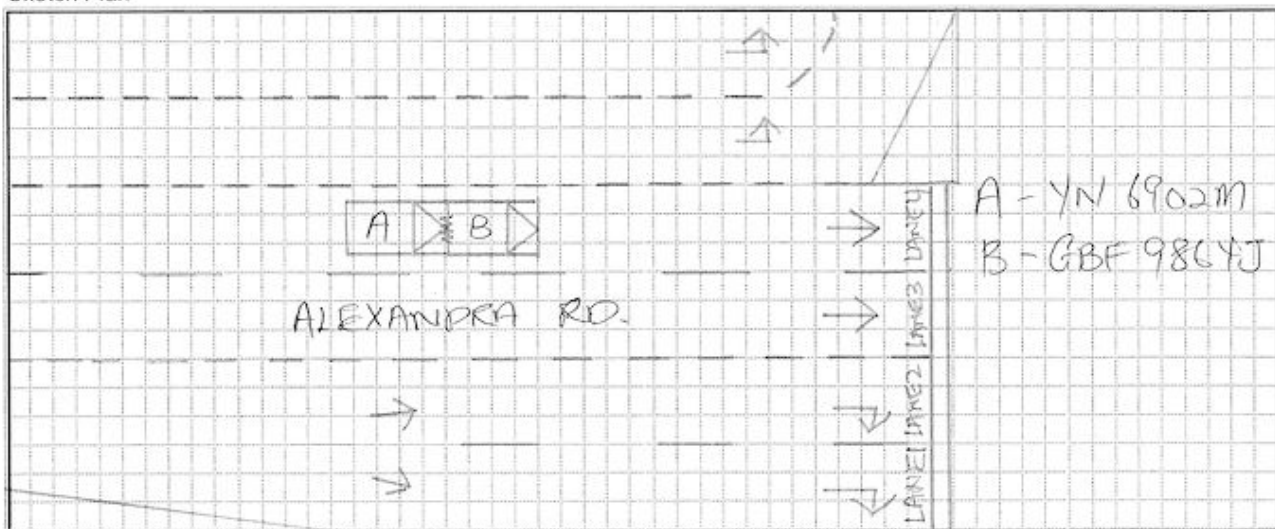

I WAS PREPARING TO REPORT THE ACCIDENT THE NEXT WORKING DAY BUT WAS ADVISED BY VEHICLE B (GBF9864J) DRIVER THAT HE NEEDS TO SEEK FOR HIS MANAGEMENT DIRECTION.
