Brief Details.

I was approaching the junction of Tampines Avenue 11 and Tampines Avenue 10. There was this dark colored car, from opposite direction making a right turn into Tampines Avenue 11. The said car was in stationary position, and when I was about to reached the said junction the car suddenly continue making the right turn. The traffic light was green on my favor at that point of time.

The act have caused my front to hit onto the left side of the car. The impact was quite strong which have caused myself to flung over the car. The sustained injuries mostly on the right part of my body. My right arm and right leg were stitched due to the injuries. I was warded 4 days at Changi General Hospital. I do not have any details of the driver of car. Traffic police were also at scene. I am lodging this report for necessary traffic police follow ups.
