CIRCUMSTANCES OF ACCIDENT

ON 23 AUGUST 2022 AT ABOUT 9.50AM, I WAS DRIVING MY AUDI SMP5338E ALONG PIE TOWARDS THE DIRECTION OF TUAS. NEAR THE 36KM MARK, I WAS TRAVELING ON THE EXTREME LEFT LANE, INTENDING TO EXIT PIE VIA JALAN BAHAR EXIT. THERE WAS A TRAFFIC JAM NEAR THE EXIT, MY CAR CAME TO A COMPLETE STOP. MY SEATBELT WAS PROPERLY STRAPPED ON. I WAS JUST AWAITING FOR TRAFFIC AHEAD TO MOVE WHEN MY VEHICLE WAS REAR-ENDED. I WAS NOT TRACED FOR IMPACT. I ALIGHTED FROM MY CAR AFTER IMPACT AND REALIZED THAT SLC4549A WAS THE 3RD VEHICLE AND SCW58C WAS THE 2ND VEHICLE BEING THE VEHICLE IMMEDIATELY BEHIND MINE. I WOULD CALL THIS A 3-VEHICLE CHAIN COLLISION. I HAVE VISITED ALEXANDRA HOSPITAL A&E DEPARTMENT SOON AFTER THE ACCIDENT ON 23 AUGUST 2022. I WAS GIVEN MC FOR 3 DAYS.

Describe Circumstances of the Accident

On 23 August 2022 at about 9.50am, I was driving my Audi SMP5338E along PIE towards the direction of Tuas. Near the 36km mark, I was travelling on the extreme left lane, intending to exit PIE via Jalan Bahar exit. There was a traffic jam near the exit, my car came to a complete stop. My seatbelt was properly strapped on. I was just awaiting for traffic ahead to move when my vehicle was rear-ended. I was not traced for impact. I alighted from my car after impact and realised that SLK 4549A was the 3rd vehicle and SCW587C was the 2nd vehicle being the vehicle immediately behind mine. I would call this a 3-vehicle chain collision. I have visited Alexandra Hospital A&E Department soon after the accident on 23 August 2022. I was given MC for 3 days.
