**Brief Details.**

On 22/10/2021 at about 1010hrs, I was travelling on my motorcycle FZ9325X along Stevens Road towards Scotts Road and it was a 2 lane road. I could not recall which lane I was travelling on.

While I was riding, a vehicle SCJ882H Collided to my rear and I fall to my left. Shortly later, Traffic Police and Ambulance came. I was then conveyed to TTSH and I was hospitalize for 1 day (22/10/2021 - 23/10/2021).

I was diagnosed with Closed fracture of scapula, closed fracture of clavicle and closed fracture rib, my right hand suffered abrasion, left shoulder suffered abrasion and left knee suffered abrasion as well.

I was given 28 days of MC from 22/10/2021 to 18/11/2021 and hospitalization leave for 60 days from 19/11/2021 to 17/01/2022.

I would like to state that I am unsure what is the damages to my motorcycle and currently my motorcycle is in Traffic Police compound.
