CIRCUMSTANCES OF ACCIDENT

ON 28 AUGUST 2022 AT APPROXIMATELY 6.10PM, I WAS DRIVING HOME ALONG RIVERINA CRESCENT TO HEAD TO MY PLACE OF RESIDENCE. JUST OUTSIDE THE HOUSES LOCATED AT 63 RIVERINA CRESCENT, THERE WAS A CONTAINER PLACED OUTSIDE HOUSE NUMBER 63. THERE WAS A CAR PARKED ON THE OTHER SIDE OF THE ROAD (DIAGONALLY OPPOSITE) TO THE CONTAINER. HENCE, I NEEDED TO DRIVE AT A DIAGONAL TO PASS THROUGH. HOWEVER, AT THAT POINT IN TIME, A LADY WAS WALKING TWO BIG DOGS AND APPEARED IN FRONT OF THE CAR. AS SUCH I HAD TO SWERVE LEFT TO AVOID HITTING HER AND THE 2 DOGS. AS A RESULT, THE SIDE OF MY CAR HIT THE CONTAINER. A METAL SPROCKET WAS PROTRUDING OUT FROM THE CONTAINER (WHICH CANNOT BE SEEN FROM INSIDE THE CAR. WE ONLY DISCOVERED THIS LATER ON) AND THIS MUST HAVE CAUSED THE LARGE TEAR TO THE LEFT SIDE OF THE CAR. NOTE: THE CONTAINER REFERS TO THE SOLID CONTAINER USED FOR RENOVATION TO COLLECT DEBRIS.

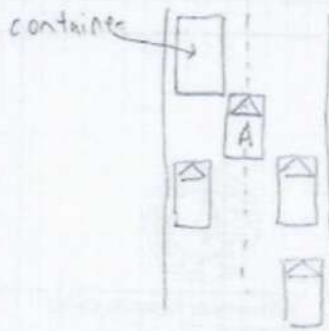

Describe Circumstances of the Accident

On 28 August 2022 at approximately 6:10 pm, I was driving home along Riverina Crescent to head to my place of residence. Just outside the houses located at 63 Riverina Crescent, there was a container placed outside house number 63. There was a car parked on the other side of the road (opposite diagonally opposite) to the container. Hence, I needed to drive at a diagonal to pass through. However, at that point in time, a lady was walking two big dogs and appeared ~~before~~ in front of the car. As such I had to swerve to avoid ~~being~~ hitting her and the 2 dogs. ^{left}


