CONTINUATION OF REPORT**Brief Details.**

On the 1 August 2022 at around 3pm, I had parked my vehicle bearing plate number SJA7462E at the carpark of Block 118 Hougang Avenue for lunch. I came back to my Car at night and noticed that there was scratches and paint chips on the right front bumper of my vehicle. As such I viewed the dashcam of my vehicle.

The dashcam had revealed that on the 1 August 2022 at 3.29pm, a Comfort Delgro taxi bearing plate number SHA7848A which was parked to the right of my vehicle, was coming out of the lot. While maneuvering out, the vehicle had steered to the left too much and the left side of the vehicle came into contact with my front right bumper. The impact was noticeable as my own vehicle jerked. The driver of SHA7848A had braked upon impact, before taking off. He did not stop to leave a note. I wish to mention that I have a front dash camera capturing the entire incident.

I have informed my insurance of the matter as such they advised me to make a police report as it was a hit and run.

I had came to Punggol NPC to lodge a report on the 2 August 2022 but turned back home as it was too crowded.
