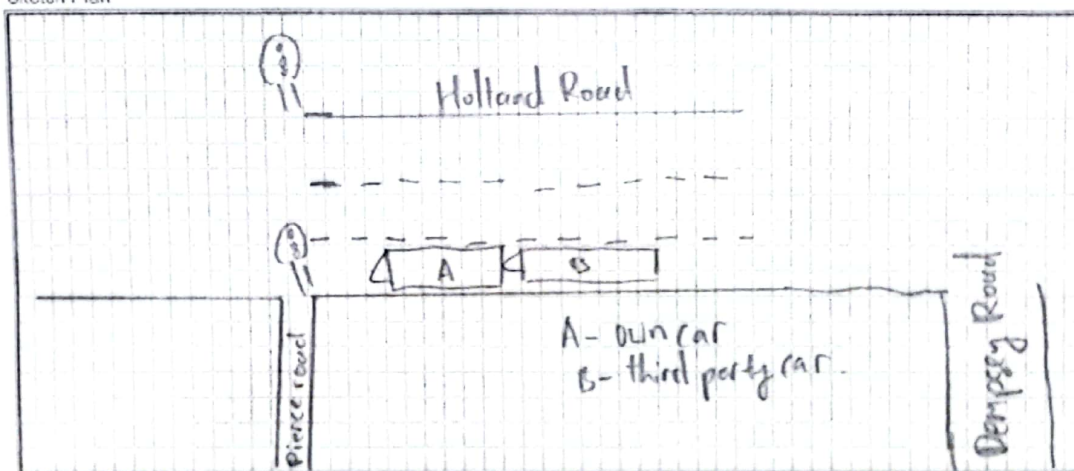


Describe Circumstance of the Accident
