**Brief Details.**

On 27/8/2022 at about 2115hrs, I was driving my taxi (SHA4669U) and fetching two passengers (one of them is Buldhiks, hp: 96272211) along CTE tunnel, heading onto TPE. While approaching a bend to go onto TPE, and with my taxi on the right lane, I heard a bang sound from the left side of my vehicle.

When I stopped my vehicle, I saw that a lorry (YN2674Y) had knocked into the left rear side of my taxi. I am unsure what had happened.

It resulted in my taxi sustaining scratches on the rear bumper area, near to the left rear wheel. I got off the taxi and made a check. My passengers did not mention that they had sustained any injuries but the son of my passenger had a shock due to this incident.

I exchange particulars with the lorry driver and took photographs of the accident. I wish to state that I have front and back dash cam footage of the accident and I have handed over the SD card to my company, Comfort Delgro, for investigation purposes.

I sustained injuries to the back of my neck and lower right side of my back. I feel sharp pain and soreness to my lower back. I was given 3 days MC from 28/8/2022 to 30/8/2022.

I have since informed my company on this matter and will be lodging an insurance claim report on Monday when the office opens.

I am lodging this report for insurance claims.


