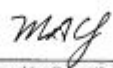

SKETCH PLAN

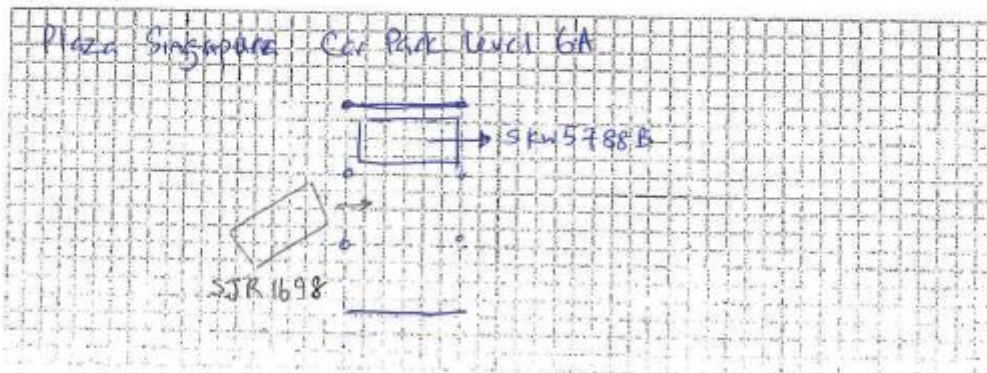

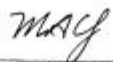
