MEDICAL REPORT ON TAN JOCK SENG - MRN NO.: S1845556J

The above-mentioned patient was seen in the Department of Emergency Medicine, Singapore General Hospital on 23 August 2022. He was registered at 1028hrs. He was attended by Dr Patrick Kong Man Ching.

He was sent in by ambulance. He alleged that he was travelling as a motorcyclist in the same morning when a taxi turned and hit the left rear end of the bike. He complained of fall to the right side and had pain over his right knee, right shoulder and right scalp after the accident. He was noted to have previous right knee injury from road traffic accident also.

Clinically his vital signs were stable. His Glasgow coma score was full and normal. There was tenderness over his right posterior auricular region, and also over his right shoulder superior aspect with abrasion. There was mild swelling and abrasion noted over his right knee.

Chest X-rays, right shoulder and right knee X-rays and CT scan of his brain did not show any fracture or dislocation.

He was diagnosed and treated for contusion and stable head injury. He was seen by the Orthopaedic doctor on duty.

He was admitted to the Short Stay Emergency Observation ward for monitoring and he was eventually discharged in the same occasion. He was given outpatient appointment to the Orthopaedic Surgeon for follow up of his injuries. He was covered with hospitalization leave from 23 August 2022 to 29 August 2022.

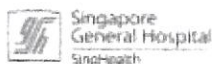

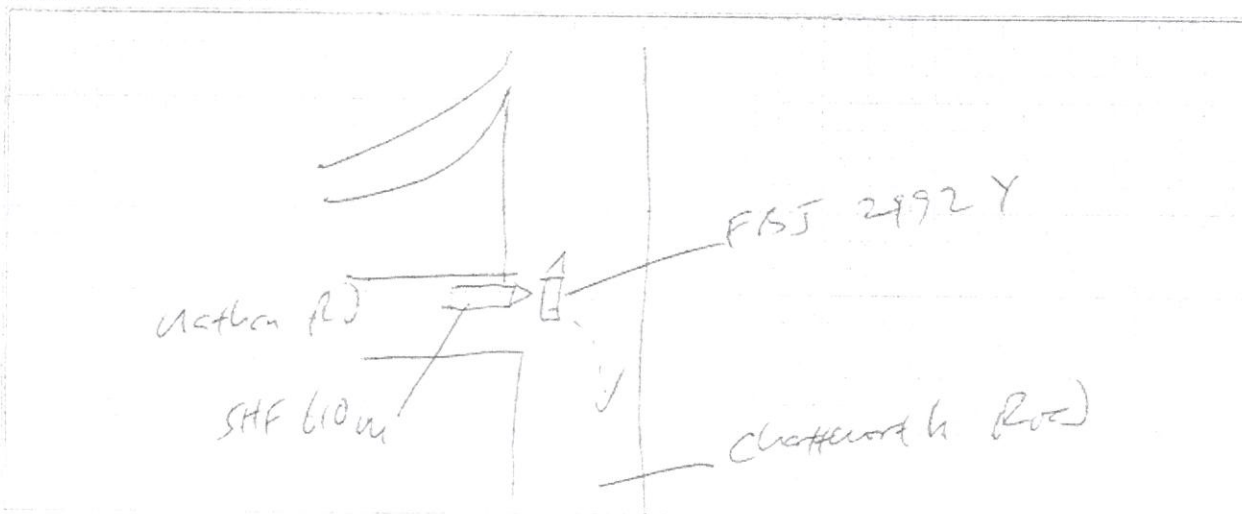

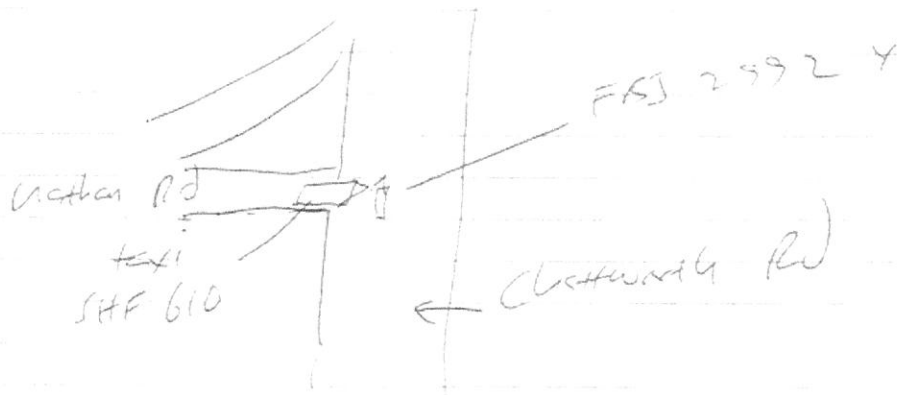
