SKETCH PLAN

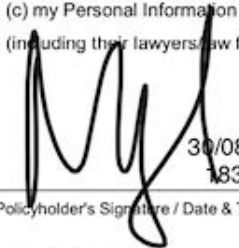

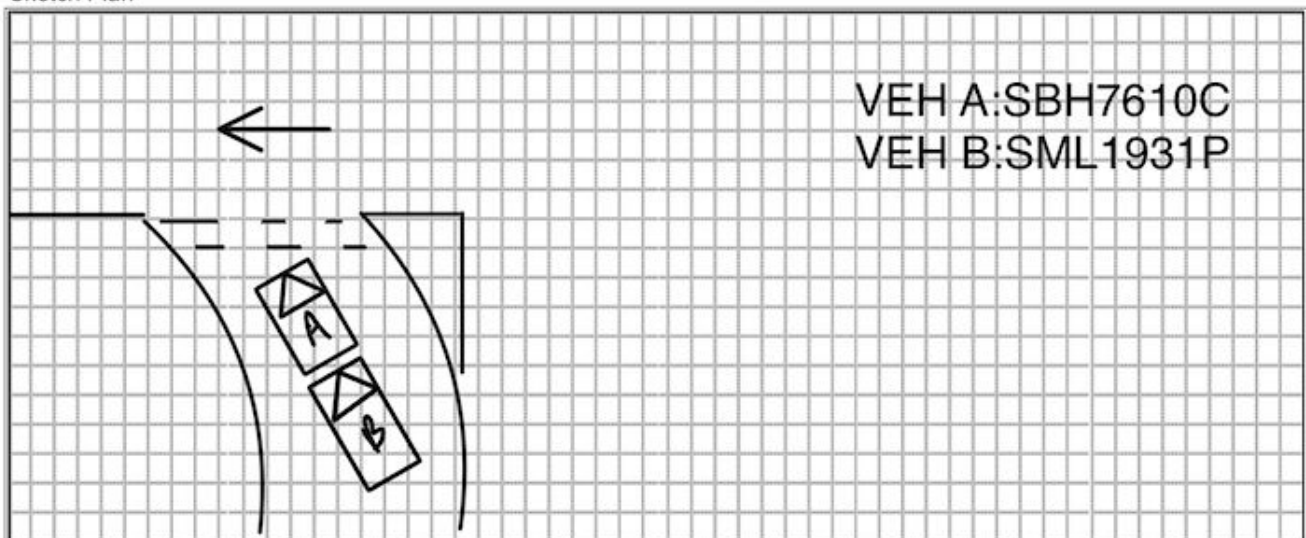
